RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

The undersigned hereby represents that he/she is the parent or legal guardian of _____ (“my child”) and that as partial consideration for enrolling my child, and allowing my child to participate in the America’s Healthy Kids exercise program (the “Program”), the undersigned hereby acknowledges and agrees as follows:

1. I have voluntarily enrolled my child in the Program, with the full and complete understanding that although the Program is designed for children of similar age as my child, participation in the Program as with any other form of physical activity (whether or not the same is organized) could potentially result in injury to, or the death of, my child. Accordingly, I hereby accept on my child’s behalf full responsibility for any and all risks of injury, death or property damage arising out of or relating to my child’s participation in the Program, from whatever cause whatsoever.

2. I hereby release, waive, discharge and covenant not to sue America’s Healthy Kids, Inc. its parent, subsidiary and affiliated companies, its and their respective officers, agents, directors, employees, licensees and invitees (collectively referred to in this document as “America’s Healthy Kids”), from and of any and all loss or damage, and any claim or demands therefore on account of any injury to or the death of my child arising out of or related to my child’s participation in the Program. Further, I agree to indemnify, protect, defend and hold harmless America’s Healthy Kids from and of each and every loss, damages, liabilities, claims demands, actions or causes of action arising out of or relating to my child’s participation in the Program.

3. I agree that this Release and Waiver of Liability, Assumption of Risk and Indemnity Agreement extends to all acts of ordinary negligence by the releases, and is intended to be as broad and inclusive as is permitted by the laws of California and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

4. I hereby grant to America’s Healthy Kids, Inc., and their successors, assigns, and licensees, permission to photograph my child, record my child’s voice, reproduce my child’s voice and picture, and use my child’s name, voice and picture in and in connection with advertising, publicity and promotional activities related to the Program, in all media now existing or hereafter created, including, but not limited to, printed materials, cable television and computer on-line services.
