III. School Climate

School Safety Plan (School Year 2011–12)

Student safety is a primary concern at Mountain Avenue Elementary and is monitored constantly by every staff member. Our head custodian arrives at 6:30 a.m., and his first duty is to walk the perimeter of our campus. Our doors and gates lock as soon as the tardy bell rings. All visitors to the campus must report to the front office, sign in, and obtain a visitor's pass that must be displayed at all times.

Our Safety Plan is evaluated and revised bi-annually every autumn and spring by members of the School Site Council and Emergency Preparedness team. These revisions are shared with all staff as well as our parent community. The key elements of our School Safety Plan is to create a safe and secure environment that promotes good attendance; create a physical environment that communicates respect for learning and for individuals; and use scientifically research-based program relating to violence and substance abuse to educate our students.

We have created detailed maps for egress/ingress in case of emergencies. Each classroom is equipped with walkie-talkies to communicate with our office, custodian, and administrator. These are kept on in case of emergencies, and are used during the monthly drills as well. Each month we conduct a self-inspection of our facilities and grounds and use that information to maintain our campus safe and clean.

Our buildings were originally constructed in 1967. Measure K projects were completed in 2005 and include a new building we call The Lodge (that houses our first and third grade classrooms), and new roofing was installed in the kindergarten classrooms. In 2008, green turf was added to our Kindergarten playgrounds, 10 LCD projectors were installed in classrooms, and document cameras purchased for classrooms. Our school grounds are well maintained, and the grass and foliage on our grounds are well kept and manicured.

IX. Student Performance

Standardized Testing and Reporting Program

The Standardized Testing and Reporting (STAR) Program consists of several key components, including:

- **California Standards Tests (CSTs)**, which include English-language arts (ELA) and mathematics in grades two through eleven; science in grades five, eight, and nine through eleven; and history-social science in grades eight, and nine through eleven.
- California Modified Assessment (CMA), an alternate assessment that is based on modified achievement standards in ELA for grades three through eleven; mathematics for grades three through seven, Algebra I, and Geometry; and science in grades five and eight, and Life Science in grade ten. The CMA is designed to assess those students whose disabilities preclude them from achieving grade-level proficiency on an assessment of the California content standards with or without accommodations.
- California Alternate Performance Assessment (CAPA), includes ELA and mathematics in grades two through eleven, and science for grades five, eight, and ten. The CAPA is given to those students with significant cognitive disabilities whose disabilities prevent them from taking either the CSTs with accommodations or modifications or the CMA with accommodations.

The assessments under the STAR Program show how well students are doing in relation to the state content standards. On each of these assessments, student scores are reported as performance levels.
