## **School Parent Involvement Policy 2018-2019**

### Statement of Purpose

The staff at Thomas Edison Elementary is committed to the goal of providing quality education for every student. It is the goal to establish partnerships with parents and the community to encourage greater involvement and to promote high achievement by all students.

Grade level standards for all students are distributed to all parents, with the expectation that all children will meet these standards. The District's core curriculum is supplemented through categorical programs to improve student achievement in basic and advanced skills. Edison will include parents in all aspects of its program in compliance with legal requirements (PL 100-297, Section 1118 Parent Involvement) and in accordance with our philosophy of guiding parents towards fulfilling that responsibility.

The Glendale Board of Education recognizes that parents/guardians are their student's first and most influential teachers and that continued parental involvement in the education of students contributes greatly to student achievement and a positive school environment.

## Parental Involvement in Developing the Policy

- I will provide opportunities for parent engagement & involvement.

### B. Parents' responsibilities include:

- I will make sure my child neatly completes and returns any assigned work.
- I will make sure that my child arrives at school on time every day.
- I will listen to and/or read to the school messages.
- I will make sure to provide the school with updated contact information.
- I will read all school communications and return the signed Thursday Folder the next day.
- I will do my best to attend Back-to-School Night, Parent-Teacher-Student Conferences, Open House and any other school events.
- I will make sure my child reads nightly.
- I will provide a quiet place and time for my child to do any assigned work.
- I will make sure my child gets adequate sleep and has a healthy diet.
- I will volunteer at school, when my schedule allows. I will ensure that I volunteer in some way, whether at school or working on a project from home.
- I will refer to the Parent Handbook for school rules and policies (available on the school website).
- I will support the class and school discipline policies, which I have read and understood.
- I will make sure that TV, video games and other extra curricular activities do not interfere with my child's education.
- I will send a signed absence note after each of my child's absences. (Note must be submitted within 3 days of an absence).
- I will ensure that my child adheres to the school uniform policy.

#### C. Students' responsibilities include:

- I will get to class on time every day unless I am ill.
- I will take my Thursday Folder home to my parent(s) and return it, signed, the next day.
- I will neatly complete and return any assigned work.
- I will take corrected work home to my parent(s).
- I will be responsible for my own behavior by following classroom and school rules.
- I will be a cooperative learner and complete my work every day.

- assigned work.
- I will read at least 20 minutes (K- 2<sup>nd</sup> grade) or 30 minutes (3<sup>rd</sup> 6<sup>th</sup> grade) daily.
- I will be responsible for any materials, including any technology that is assigned to me.
- I will adhere to the school uniform policy.

#### D. Ongoing communication between teachers and parents include:

- Frequent reports to parents on their child's progress
- Reasonable access to staff
- Teacher Websites- check regularly for updates
- Opportunities to volunteer and participate in the child's class
- Observation of classroom activities
