

Purpose of Title I

According to the U.S. Department of Education the purpose of Title 1 funding, "is to ensure that all children have a fair, equal, and significant opportunity to obtain a high quality education and reach, at minimum, proficiency on challenging state academic achievement standards and state academic assessments."

Title I Funding

- Schools where at least 40 percent of the children in the school attendance area are from lowincome families or
- at least 40 percent of the student enrollment are from low-income families that are eligible to receive federal Title I funds.
- The proportion of low-income families is most frequently measured by the percent of students receiving free and reduced-price lunch.
- Title I funds are to be used for programs designed to improve the academic achievement of children from low-income homes.
- Formula is:
 - # of free and reduced lunch count as of 10/3/18 number of CALPADS enrollment

NOTICE TO PARENTS/GUARDIANS/PUPILS/TEACHERS/STAFF:

COMPLAINT RIGHTS

Parents/Guardians/Pupils/Teachers/Staff:

Education Code 35186(f) requires that the following notice be posted in all classrooms.

- There should be sufficient textbooks and instructional materials. For there
 to be sufficient textbooks and instructional materials, each pupil, including
 English learners, must have textbooks or instructional materials, or both, to
 use in class and to take home.
- School facilities must be clean, safe, and maintained in good repair. Good repair means that the facility is maintained in a manner that assures that it is clean, safe, and functional as determined by the Office of Public School Construction.
- Each class should be assigned a teacher and not a series of substitutes or other temporary teachers. The teacher should have the proper credential and subject matter training to teach the class, including training to teach English learners, if present.
- Pupils should not be charged fees or be required to make a purchase in order to participate in a class or extracurricular activity.
- To file a complaint regarding the above matters, complaint forms can be obtained at the Principal's Office or from the Director of Categorical Programs Office at the Glendale Unified School District Administration Building, 223 North Jackson Street, Glendale, California.



Maximize Student Achievement- All students will reach high standards, at a minimum, attaining proficiency or better in Language Arts.

English Language Arts Goal:

Based on the 2017-2018 CAASPP test scores, only 51% of our students in grades 3- 6 met (32%) or exceeded (20%) grade level standards. 49% of our students are not proficient in ELA.

The goal will be to increase the number of of students meeting and exceeding grade level standards in ELA by at least 5% by May 2020.

Maximize Student Achievement- All students will reach high standards, at a minimum, attaining proficiency or better in Math.

Math Goal:

Based on the 2017-2018 CAASPP test scores, only 43% of our students in grades 3- 6 met (25%) or exceeded (18%) grade level standards. 57% of our students are not proficient in math.

The goal will be to increase the number of students meeting and exceeding grade level standards in Math by at least 5% by May 2020.

Increase engagement

All Hispanic, Socio-economically disadvantaged, and students with disabilities will reach high standards, at a minimum, attaining proficiency or better in reading and mathematics by May 2020.

In the CA Dashboard, Edison's overall academic achievement for our English Learner, Hispanic, Students with Disabilities and Socio-Economically Disadvantaged sub groups, show a gap among their peers.

Create a culture of learning

Edison students will feel safe in all areas of the school at all times and will participate in a healthy lifestyle. The school will ensure that we have the proper equipment, training and plans to ensure safety throughout the school year and in case of any emergencies. PBIS will continue to be implemented as a school wide effort to improve our school environment.
