#### **Summary of Educational Funding**

- **\$1.8 Billion** reduce inter-year deferrals Goal: Eliminate deferrals by end of 2016-17
- \$1.6 Billion implement Local Control Funding Formula (\$15 billion needed to fully implement)
- **\$400.5 Million** energy efficiency projects in schools
- \$100 Million Mandate Block Grant (Graduation Requirements and Behavioral Intervention Plan mandates)
- **\$62.8 Million** 1.65% COLA (Special Education, Transportation?, TIIG?)



## Local Control Funding Formula (LCFF)

Local Control Funding Formula (LCFF)

- Replace Revenue Limits and Categorical Funding (except: Special Education, Transportation, TIIG)
- Phase in over 7 years (fully implement by 2020-21)
- District Plan for Student Achievement to be Concurrently Adopted with the Annual Budget

Local Control Funding Formula (LCFF) – Cont.

Per Student Supplemental Grant – 35%

Eligible Students: English Learners, Free and Reduced-Price Meals Program, Foster Care (53% - 56%)

Per Student Concentration Grant -35%

Eligible Students exceed 50% of Total Enrollment (fund those exceeding 50% level; 3% - 6%)

# **Governor's Budget Proposals for 2013-14** District Plan for Student Achievement

- The District Plan must address at least the following:
  - Basic conditions for student achievement (qualified teachers, sufficient materials, school facilities – Williams type elements)
  - 2. Programs or instruction for low-income and English language learners
  - 3. Implementation of Common Core Standards (progress toward college and career readiness as measured by the API, graduation rates, completion of college-prep and CTE courses)



#### **District Plan for Student Achievement (Cont.)**

- Department of Finance suggests that no State agency would review the District Plans
- Instead the K-12 Audit Guide would be revised to require independent auditors to verify the Plans contain all mandatory elements and related expenditures



Opportunity to Evaluate/Redesign Instructional Programs as Categorical Dollars are Phased Out.



- Deferred Maintenance
  - > Will be part of the LCFF base grant
  - No local contribution is required to receive the funds
    - $\,\circ\,\,$  Concern Funds will be needed after Measure S

- Routine Restricted Maintenance
  - Elimination of minimum 3% contribution requirement for routine maintenance
  - Need to evaluate maintenance needs and plan as part of General Fund expenditures
  - Majority of expenditures are classified salaries and benefits and materials and supplies

## CONCERNS

- Formulas and Phasing Plan Need to be Finalized
- Laws Need to be Changed
  - Unemployment Reimbursement <u>Eliminated</u>? \$1.5 to \$2.2 M
- State Must have \$\$ to Reach 2020-21 Target
- Proposition 30 Revenue will end
