

# John C. Fremont Elementary School Parent and Family Engagement Policy



## (GUSD Board Policy 6020)

The Glendale Unified School District Board of Education recognizes that parents/guardians are their children's first and most influential teachers and that sustained parent involvement in the education of their children contributes greatly to student achievement and a positive school environment. The Superintendent or designee shall work with staff and parents/guardians to develop meaningful opportunities at all grade levels for parents/guardians to be involved in district and school activities; advisory, decision-making, and advocacy roles; and activities to support learning at home.

Parents/guardians shall be notified of their rights to be informed about and to participate in their children's education and of the opportunities available to them to do so.

The Superintendent or designee shall regularly evaluate and report to the Board on the effectiveness of the District's parent involvement efforts, including, but not limited to, input from parents/guardians and school staff on the adequacy of parent involvement opportunities and barriers that may inhibit parent/guardian participation.

# **Statement of Purpose**

John C. Fremont Elementary School is committed to the goal of providing quality education for every student. It is the goal to establish partnerships with parents and the community to encourage greater involvement and to promote high achievement by all students.

The Glendale Board of Education recognizes that parents/guardians are their student's first and most influential teachers and that continued parental involvement in the education of students contributes greatly to student achievement and a positive school environment.

#### **Parental Involvement**

John C. Fremont Elementary School shall jointly develop with and distribute to, parents of participating students a written Parent and Family Engagement Policy, agreed on by such parents that shall describe the means for carrying out all requirements for parent involvement. The policy is in an understandable and uniform format and, to the extent practicable, provided in a language that parents can understand. #### The school shall:

- Provide advice on all matters related to parental involvement in funded programs.

#### **Visitors and Volunteers**

ALL volunteers in public schools who have contact with students for 15 or more hours per school year must:

- comply with the GUSD Tuberculosis (TB) policy and all applicable health guidelines, and have that information entered into the office Raptor System.
- Show proof of Covid vaccine or a negative Covid test within 48 hours of volunteering.
- Have fingerprint clearance.
- \* Fremont will follow most current District guidelines, which may change at any time.

### **Parent-School Compact**

John C. Fremont Elementary School, a nurturing, learning environment that values the special talents of each student, will empower students to realize their personal potential, build character, develop independence, and become responsible decision makers, through varied experiences and active learning, utilizing the combined efforts of family, school, and community. Our school shall provide:
