## **Statement of Purpose**

Marshall Elementary School is committed to providing high quality education for every students by using Common Core State Standards (CCSS) based Instructional program. CCSS is explained and discussed each year at Back to School Night. Family support for their children and for the school is vital to their children's emotional, social, and academic success.

Parent and Family Engagement research demonstrates that when schools create family partnerships, student learning is better supported and higher student achievement is attained. Students whose families are part of their school-life earn better grades and higher test scores, attend school more regularly, exhibit better social skills, and adapt better to school. Family participation, such as actively monitoring a child's time, helping with homework, and discussing school matters, creates students who are more likely to go on to postsecondary education – even to better schools!

### Parent Meetings/Involvement

At John Marshall we make every effort to provide our Families with information relating to all aspects of the School-wide programs, including its design, implementation, and evaluation. In addition to school-wide and Title I Parent meetings we held School Site Council meetings in conjunction with the English Language Advisory Committee. Parents receive copies of the District's current Parent Compact during Back to the School Night and the new enrollees receive theirs with the enrollment papers. Oral translations in Spanish and Armenian, as well as written translations of materials, are made available at the meetings and upon request. All families in the school are sent written notices about meetings and school-wide events and activities. The families also receive Blackboard Connect phone calls from the principal informing them about the upcoming events and meetings. The marquee in front of the school also highlights parent meetings and school events.

In addition to parent meetings, all parents are encouraged to participate as classroom volunteers and as School Site Council and committee representatives.

The marquee in front of the school also highlights parent meetings and events. Communications are sent home in Thursday folders in various languages regarding school and district events. Translators are available for conferences with parents. Teachers are provided with parent phone numbers for each student in order to facilitate communication.
