
An invitation will be sent to all who attended the mandatory pre-bid conference and job walk.

Request for Clarification/Questions:

Question #1: Item 8 under scope of work identifies a new 24 inch concrete bench. Please provide a detail so we may be able to price out the scope, (Wilson MS)

ANSWER: Please see Drawings



Question #2: Item 11 under scope of work identifies a 30'x20' stage. Please provide a detail for the stage so we may be able to price out the scope, (Wilson MS).

ANSWER: There are no detail drawings for the stage, but it's a solid 20 x 30 inch x 24 inches high stage with #4 rebar at every 18 inches, two inches from the bottom and 2 inches from the top, with same skate deterrent in the stage same as the seat benching. Very similar design as the benches but at 20 x 30 fee

Question #3: Item 16 under scope of work identifies to reuse or lower utility boxes. Please provide size and quantity of each type of box so we may be able to price out the scope, (Wilson MS).

Answer: During the Job walk, opportunity was made to take measurements and counts for all boxes and sizes and it's the responsibility of the contractor to precise measurements, that is why measurements were are given as estimates or approximate measures.

Question #4: Item 18 under scope of work identifies 6" pipe with 18"x18" and 12"x12" catch basins. Please provide a quantity and material for the 6" drain pipe. Also provide a manufacturer and a model number for the catch basins so we may be able to price out the scope, (Wilson MS).

Answer: The length of the piping is approximately 475 linear feet of 6" pipe, with a high traffic concrete catch basins and grates, manufacturer and model of catch basins is non-specific.
