General Information:

1. **Revise Bid Form, Document 00 41 13, Paragraph 2 – Allowance:** to be in the amount of **one hundred thousand dollars (\$100,000.00)** for Unforeseen work not shown within the Contract documents. For Demolition, shoring, and boring, drilling, storm drains, A/C paving, Landscape, irrigation, fencing, handrails, unforeseen underground utilities, High and low voltage electrical data line and cabling, concrete footings and structural, steel frame structural, foundation steel deck and Testing and inspection anything related to the Glenoaks Interim Housing Building Project. The Bidders Base Bid shall NOT include the Allowance. Contractor shall be permitted to invoice for Work under the Allowance in the identical structure as a Change Order.
