The project(s) consists of: Demolition and Replacement of Driveway Apron, Sidewalk and a portion of Driveway, per Plans.

Sealed bids shall be received until **2:00 p.m., June 18, 2019**, at the District Office, located at **223 N. Jackson Street, Room 305, Glendale, California**, at or after which time the bids will be opened and publicly read aloud. Any claim by a bidder of error in its bid must be made in compliance with section 5100 et seq. of the Public Contract Code. Any bid that is submitted after this time shall be non-responsive and returned to the bidder.

A bidders' conference will be held on June 11, 2019, at 9:00 a.m. at Verdugo Woodland ES, 1751 N. Verdugo Rd., Glendale, CA 91208, for the purpose of acquainting all prospective contractors with the bid documents and the work site. Contractors are required to visit the site prior to bidding this project and a Site Certification will be required as part of your bid package submitted to the district.

Each bid must conform and be fully responsive to all documents comprising the Contract Documents.

Each bid shall be made on the Bid Form prepared by the District in the Contract Documents.

Contractor and its subcontractors shall pay all workers on the Project not less than the general prevailing rate of per diem wages and the general prevailing rate for holiday and overtime work as determined by the Director of the Department of Industrial Relations, State of California, for the type of work performed and the locality in which the work is to be performed within the boundaries of the District, pursuant to sections 1770 et seq. of the California Labor Code. Prevailing wage rates are available from the District or on the Internet at: http://www.dir.ca.gov. Contractor and its subcontractors shall comply with the registration and qualification requirements pursuant to sections 1725.5 and 1771.1 of the California Labor Code.

The substitution of appropriate securities in lieu of retention amounts from progress payments in accordance with Public Contract Code Section 22300 is permitted.

A bid bond by an admitted surety insurer on the form provided by the District, cash, or a cashier's check or a certified check, drawn to the order of the District, in the amount of ten percent (10%) of the total bid price, shall accompany the Bid Form, as a guarantee that the Contractor will, within seven (7) calendar days after the Notice to Proceed or other direction, enter into a contract with the District for the performance of the Services as stipulated in the bid. In addition, a one hundred percent (100%) Performance Bond and a one hundred percent (100%) Payment Bond will be required of the successful bidder.

Each bid must include the name and location of the place of business of each subcontractor who shall perform/work of this Contract in excess of one-half of one percent (1/2 of 1%) of the bid price.

No bid may be withdrawn for a period of sixty (60) days after the date set for the opening for bids except as provided pursuant to Public Contract Code Sections 5100 *et seq*.

The District reserves the right to reject any and all bids and to waive any informalities or irregularities in the bidding.

The District shall award the Contract, if it awards it at all, to the lowest responsive responsible bidder based on the base bid amount.
