6. Item #67 - Model XAVL-2021, do you need right hand control (add -DPRS to model) or left hand control (add -DPLS to model)?

<u>Response:</u> We will add UNOX Model XAVL-2021-DPRS for right hand control.

7. Item #77 - Model requested #15-0051MOD is invalid. The closest match is model #150-0051MOD.

<u>Response:</u> 150051-MOD is the correct model, see spec sheet attached. It's a modified 63.75 in. height non-insulated transport cabinet with vertical bail handles instead of

horizontal.

- 8. <u>Piggyback Clause</u> I liked to take exception on the delivery, installation and haul away of equipment. We can only allowed piggyback on equipment price. Will that disqualify me from this bid?


