# Need for Glendale Unified Students to Return to In-Person Instruction

- Schools play a critical role in the wellbeing of communities by:
  - Providing safe and supportive environments, structure, and routines for children.
  - Providing social interaction and opportunities to promote language, communication, social and interpersonal skills for students who experience social isolation and increased anxiety.
  - Providing other needed support services to children and families.
  - Addressing disparities in educational outcomes for students who did not have the capacity to fully participate in distance learning.

#### Glendale Unified Mask Protocols

- Masks required indoors for everyone, regardless of vaccination status. Masks are voluntary outdoors; strongly recommended when physical distancing is not feasible.
- Employees medically exempted from wearing a mask indoors must wear a face shield with drape and be tested at least 2x per week.
- Students exempted from wearing a mask indoors due to disability or other medical condition must wear a face shield with drape and will not be excluded from in-person education; strongly recommend such students be tested at least 2x per week.
- Students participating in P.E. or sports indoors must wear a mask.
- Music and chorus may be indoors if students and staff are wearing a mask; special music masks that fit around mouthpieces are allowed when used with bell covers for all wind instruments.
- Students who are excluded from campus because they will not wear a face covering may enroll in independent study.

#### Glendale Unified Quarantine Protocols

- Staff will continue to follow all guidelines for quarantine, isolation, contact tracing, notification, and testing should a COVID-19 exposure occur.
- Exposure is defined as proximity to the positive case for 15 minutes or more over a 24-hour period on the days of exposure.
- Unvaccinated or partially-vaccinated individuals who are close contacts to a positive case must quarantine for 8-10 days.
  - Testing will be offered on day 6.
  - If individual tests negative on day 6, they may return on day 8 if they are asymptomatic.
  - Any individual refusing to get tested will have to quarantine the full 10 days.
- Fully vaccinated individuals who are close contacts to a case do not need to quarantine, but it is strongly recommended that they be tested after exposure.

# Glendale Unified Contact Tracing & Notification Protocols

- Individuals identified as close contacts to a COVID-19 exposure will receive a phone call from a Glendale Unified health care personnel and be offered a PCR test.
   Glendale Unified has significantly increased staff to assist with contact tracing and notification.
- Employees and parents/guardians of students who are on campus or in a district facility at the time of exposure but not identified as a close contacts will receive a courtesy notification email.
- Confirmed COVID-19 cases at school and district facilities are reported for the public in an online database at <a href="www.gusd.net/COVID19Dashboard">www.gusd.net/COVID19Dashboard</a>.



# Glendale Unified Health Screening & Testing Protocols

- Ruvna health screening will continue at all school and district facilities. Practice notifications will be sent to all families on August 16 and August 17.
- Health care professionals will be assigned to every school site from 7:30 a.m. to 4:00 p.m. every school day to conduct testing.
- Asymptomatic testing is available and encouraged for all students and employees.
  - Opt-in form will be sent to families to give permission to test students without a parent/guardian having to be present.


#### Campus Readiness

#### Deep Cleaning

- 90% of schools have been deep cleaned.
- Remainder of rooms are currently in use and will be deep cleaned later this month.

#### Refinishing Floors

- 90% of elementary school rooms completed.
   Remainder of rooms are currently in use and will be refinished later this month.
- 75-80% of middle school rooms completed.
   Remainder of rooms will be refinished during school year.
- High school floors will be refinished throughout the school year, which is normal practice.





#### Campus Readiness

- MERV 13 Filters Replacement filters are installed as-needed, typically once every 4 to 6 months. All school sites will be completed by August 18.
- HEPA Filters Every classroom, office, library, cafeteria, exercise area, and staff lounge is equipped with a Blue Air HEPA floor unit.
- HVAC systems are being tested for proper and optimal operation.
- Functional windows in classrooms are in working order and additional window opening rods to reach higher windows have been delivered to sites.







#### Campus Readiness

- Handwashing Stations Over 450 portable and fixed handwashing stations have been added across all school sites.
- Drinking Fountains In accordance with Public Health guidance, water fountains and bottle filling stations are being turned back on and conditioned for public use.
- Tents 30 tents are installed at school sites districtwide. Additional tents for outdoor learning, gathering, and quarantine space are being provided to schools upon request.





#### Free Meals for Students

- USDA waiver for the National School Lunch Program's Seamless Summer Option has been extended through June 30, 2022.
- Free breakfast and lunch available for ALL students.
- Free after school snacks available for students attending an after school program.
- In order to qualify for certain State and Federal funds, GUSD requests all parents complete a Household Income Survey to identify families who would have qualified for free/reduced meals.









#### Before and After School Care



#### Before and After School Care 2021-22

- Glendale Unified will offer no-cost child care at all elementary schools.
- Before and after care are available all school days.
- Morning care begins at 6:30 a.m. until school begins.
- After care begins upon student dismissal and is available until 6:00 p.m.
- Snacks will be provided at no cost to families.
- Child care is staffed by GUSD Child Care teachers and assistants
- Student-to-adult ratios = 10:1 in TK/K and 20:1 in grades 1-6.
- Students will remain in stable grade level groupings and rotate through a variety of engaging activities.
- Additional child care opportunities will be available at a cost to families (i.e. Winter Camp, Spring Camp, etc.)

- On August 5, registration was paused in order to ensure we hire enough staff to provide appropriate supervision.
- Hiring is on-going which will increase capacity to serve all families who wish to access child care this year.



#### Child Care Program Highlights

- Children will have time to:
  - Complete homework.
  - Participate in structured physical activities.
  - Engage in enrichment activities that emphasize social emotional health, student voice, and agency.

### Independent Study



#### Glendale Unified Independent Study

- The State's emergency legislation that temporarily allowed school districts to provide distance learning expired on June 30, 2021.
- AB 130 (July 9, 2021) requires districts make independent study an option for eligible students whose health or other personal circumstances make a return to on-campus instruction difficult.
- Students will have rights to return to their home school for the 2022-23 school year or within five days upon request during the 2021-22 school year.
- Students with special needs will need to have their IEPs modified to address the request for independent study and adjust services.



#### Glendale Unified Independent Study

- Informational webinar was held on August 9 to share information and next steps for families; questions were collected to be included in the Independent Study FAQ.
- Webinar and commitment form links were emailed to every family who expressed an interest in independent study.
- Students will be enrolled in the independent study program as soon as the commitment form is received.





# Independent Study Support for Students with IEPs & Students in Dual Immersion Programs

- Students with Individualized Education Plans (IEPs):
  - Prior Written Notice will be provided allowing for 30 day diagnostic placement.
  - Related services will be provided as independent study by the provider.
  - o IEP team meeting will be held to discuss appropriateness of independent study for each individual student within 30 days.
- Students in Dual Immersion Programs (58 students as of August 10):
  - Target language learning will include lessons with an instructor for live interaction and practice.
  - Students and families will be able to check out materials and access online resources in their target language if available to maintain dual immersion study.
  - Content instruction will be provided in English by the teacher of record.








### First Day of School
