- Interactive Lessons from Common Sense Media:

- Required by Children's Internet Protection Act (CIPA) and E-Rate program.
- Designed and developed in partnership with Project Zero at the Harvard Graduate
 School of Education and guided by research with thousands of educators
- Lessons take on real challenges and digital dilemmas that students face today, giving them the skills they need to succeed as digital learners and leaders.




Drug, Tobacco, Vaping Elimination





Red Ribbon Week October 23-31, 2021

- The National Family Partnership sponsored the first Red Ribbon Campaign in 1988.
- For 33 years it has served as a catalyst to mobilize communities to educate and engage youth in drug prevention activities.



Red Ribbon Week (cont.)

- Every year, GUSD joins the Glendale Council PTA to promote Red Ribbon Week activities.
- Our elementary, middle and high schools plan a week-long list of activities to promote healthy choices and staying drug, tobacco and vape free.
- We are committed to promoting these healthy choices year round at all schools.








Tobacco, Vaping and E-cigarettes

- More than 20% of high school students reported vaping in 2018 - almost twice the 2017 rate (CDC).
- Current use rate of vaping devices among middle schoolers rose from 0.6% in 2011 to 10.5% in 2019 (Truth Initiative).
- Nicotine can harm the developing adolescent brain. The brain keeps developing until about age 25 (CDC).
- Using nicotine in adolescence can harm the parts of the brain that control attention, learning, mood, and impulse control (CDC).
- Nationally, approximately 50% of calls to poison control centers for e-cigarettes are for kids 5 years of age or younger (CDC).

Tobacco Use By High School Students

The Centers for Disease Control and Prevention says the popularity of e-cigarettes has fueled a sharp reversal in what had been a sustained decline in smoke and smokeless tobacco product use among high school students.





Responding with Education and Support

- GUSD Student Support Services provides educational presentations to students, families, and staff on the dangers of vaping.
- The Tobacco Use Prevention Education (TUPE) program continues to offer cessation classes to students who vape/use tobacco products in all 5 high schools.
- In middle schools, TUPE coordinators educate students on the dangers of vaping/tobacco through Project ABCD.
- Middle school science classes use curriculum provided through the TUPE grant to teach all students the dangers of smoking/vaping.





Responding with Education and Support

- At the high school level, students caught in possession of vaping and/or tobacco products are enrolled in a TUPE cessation class for that semester in lieu of suspension.
- Parents are always part of the conversation.
- Educating students on the dangers of using vapes or tobacco products encourages them to make the decision to quit on their own.


