




Quarterly Stakeholder Surveys

Disaggregated Survey Results (by school type)






Disaggregated Survey Results (filtered for grade level)

Live small group interaction or class



Comparative Survey Results: "Do you feel that there is enough time each day in the instructional schedule for the following activities?"


Whole class instructional time





Comparative Survey Results: "Do you feel that there is enough time each day in the instructional schedule for the following activities?"


Time for students to learn independently (asynchronous lessons)

Time for peer interaction



Technology Learning Pods Update

- 99 Technology Learning Pods across all Elementary Schools
- 1,089 TK-6 students attend daily
- Currently have a waiting list of 301 students





Specialized Services Gradual Return for Daily High School

- Welcomed back two small cohorts of students as of October 19
- 11 students total
- Following all health and safety guidelines
- Public Health visit on October 29
 - Very complimentary of preparation, equipment, signage, and protocols
 - Minor suggestions for additional signage
- Plan to expand to assist more at-risk students

 As of the week of October 19 Crescenta Valley High School, Glendale High School and Hoover High School had successfully started athletic conditioning



Specialized Services Phasing in the Return of English Learners

- Facilitated Learning Centers (FLC) for up to 12 students with one substitute teacher and one assistant
- Students continue with current distance learning schedule with option to participate in FLC or remain at home
- Estimated need of 10 FLCs across secondary schools
- Priority: Students enrolled in Emerging ELD. Students in Expanding ELD who have been in country for less than one year may be included if space allows

English Learner Instructional Day


- 9:00 a.m. 2:30 p.m. (8:00 a.m. start time at Roosevelt) Same as current distance learning schedule
- Instructional Plan = Facilitated Learning Centers
 - All students continue with Distance Learning class schedule
 - Supplement with activities during lunch and/or independent work time to practice speaking and listening/build connections
- Training for Substitute Teachers/Educational Assistants
 - Health and Safety Protocols
 - Tech Tools (Digital Citizenship, Nearpod, Kami, etc.)
 - ELD Instructional Best Practices
 - Activities/prompts to promote speaking and listening

COVID-19 Notification Process

- Phone calls to students/parents/guardians and staff identified as being directly exposed to COVID-19 at a school or district facility
- Emails to students/families and staff who were on campus on the dates of exposure, but did not come into direct contact with the individual
- Emails to students/families and staff who were present on the field/area of campus where athletic conditioning was taking place on the dates of exposure, but did not come into direct contact with the individual

Public Health Update for Specialized Services



New Guidance as of October 27

The proportion of students who may receive in-person specialized services on campus at any one time increased from 10% to 25% of full student capacity.

The 25% limit does not apply to school age children on campus for child care while engaged in distance learning. It also does not apply to students in grades TK-2 returning after granting of a school waiver.

Specialized services are available to any student defined as at-risk.

- Offer support to students who are currently assigned to self-contained classrooms, students who are most vulnerable to learning regression and struggle with distance learning
- Families would have the <u>choice</u> to remain with distance learning or to return to inperson instruction following all health and safety guidelines

- LA County Office of Public Health began accepting applications October 5, 2020
- LA County will start by <u>approving 30 schools per week, equally divided among the</u> <u>five supervisorial districts</u>
- Schools with <u>higher percentages of students qualified for free/reduced meals are</u> given priority



Mann Elementary TK-2 Reopening Waiver

- Highest poverty level of all GUSD schools (90.5%)
- Proposing a gradual return of students starting with TK/Kindergarten
- Families will be given the <u>choice</u> of staying at home with distance learning or returning to school following a hybrid model
- All health and safety protocols will be followed including size of class cohorts, wearing face masks, physical distancing, and daily temperature and health checks

• COVID Response Team has confirmed that the school has sufficient signage, equipment,


History of Outdoor Classrooms

- Outdoor classrooms are not a new concept
 - In the early 1900's, health officials encouraged open-air spaces for instruction in order to prevent the spread of tuberculosis
 - Without a vaccine to treat the disease, health professionals focused on changing behaviors and the environment
 - Open-air schools expanded throughout Europe, and soon after began opening in the U.S.



History of Outdoor Classrooms (cont.)











Considerations for Outdoor Classrooms

- Additional space to provide in-person instruction
- Fresh air and ventilation, reduces the likelihood of transmission of COVID-19
- Allows for social distancing and required spacing
- Expanded access to in-person instruction, especially for disadvantaged students
- Increases the amount of instructional space available
- Benefits social, emotional, and mental well-being
- Relatively inexpensive compared to other options
- Provides equitable access to the outdoors for students who do not live near parks
- Promotes increased physical development and activity
- Boosts problem-solving skills and reinforces teamwork
- Reduced stress, improved mood
- Space is readily available at a majority of campuses



Considerations for Outdoor Classrooms

- Weather too hot or too cold, rain, insects
- Younger students could be more distracted from learning
- Modestly increases the number of students Districts can teach in person
- Staffing of outdoor spaces in addition to indoor classrooms
- Added financial costs of about \$5,000-\$10,000 per classroom
- Group study sessions are better held inside
- Less reliable access to internet
- Decreased privacy and security
- Ambient noise may impede concentration or communication
- Amplification of teacher voices
