School Attendance Boundaries

The Board of Education shall establish school attendance boundaries in order to maximize the efficient use of district facilities and effective administration of district schools. The Superintendent or designee shall periodically review school attendance boundaries and, as necessary, make recommendations to the Board for boundary adjustments.

The Board of Education shall regularly review school and District enrollments and projected enrollments and will make every effort to ensure that students will be able to attend neighborhood schools. The Board shall hold a public hearing to secure community input before approving any boundary change.

When reviewing school attendance boundaries, the Superintendent or designee shall consider the following factors:

- 1. School enrollment data, including declining enrollment patterns.
- 2. Facility capacity and design, including potential commercial and residential developments.
- 3. School feeder patterns, including maintaining, to the extent practicable, continuity of student attendance.
- 4. Federal, state, or court mandates.
- 5. Community input.
- 6. Student safety.
- 7. Transportation capacity.
- 8. Community and neighborhood identity.
- 9. Geographic features of the district, including traffic patterns.
- 10. Educational programs, such as magnet schools and charter schools.
- 11. Consistency between municipal boundaries and high school boundaries.
- 12. Other factors.

School Attendance Boundaries

Students shall attend school in their attendance area unless otherwise authorized by the Superintendent or designee. The Superintendent or designee may place some students in a school outside of their attendance area in order to alleviate overcrowding.

Parents/guardians of students who are attending schools outside of their attendance area shall be notified of the school their child will be attending as soon as possible.

A. Elementary Schools

1. Balboa Elementary School

The attendance area of this school is that part of the Glendale Unified School District enclosed by the following described line: Starting at the western boundary of the Glendale Unified School District and the intersection of the Southern Pacific Railway, the line runs southeast on the center line of said railway to the intersection of Thompson Avenue; northeast on the center line of Thompson Avenue to the intersection of Glenwood Road; southeast on the center line of Glenwood Road to the intersection of Western Avenue; northeast on the center line of Western Avenue to the intersection of Kenneth Road; southeast on the center line of Kenneth Road to the intersection of Grandview Avenue; north on the center line of Grandview Avenue and the northern extension of Grandview Avenue; west to meet the western boundary line of the Glendale Unified School District; south following the Glendale Unified School District boundary line to the starting point.

Balboa Elementary School will be considered the home school for students who live within the Benjamin Franklin and Mark Keppel Elementary School attendance boundaries but do not enroll in those magnet school programs.

2. Cerritos Elementary School

The attendance area of this school is that part of the Glendale Unified School District enclosed by the following described line: Starting at the western boundary of the Glendale Unified School District and the extension of Garfield Avenue, the line runs east along the center line of Garfield Avenue to Brand Boulevard; south along the center line of Brand Boulevard to Palmer Avenue; east along the center

line of Palmer Avenue to Glendale Avenue; south along the center line of Glendale Avenue to the intersection of Cypress Street; east paralleling Cypress Street, excluding both sides of Cypress Street, to the intersection with the southern extension of Boynton Street; south on said extension to the intersection with the southern boundary line of the Glendale Unified School District; west and northwest following said boundary line to its starting point.

Cerritos Elementary School also accepts students who live outside the school's geographical attendance boundaries to participate in the Computer Science Immersion Magnet School.

Cerritos Elementary School will be considered the home school for students who live within the Thomas Edison Elementary School attendance boundaries but do not enroll in the magnet school program.

The western and northern limits of the Dunsmore School shall be those of the Glendale Unified School District.

- a. Siblings of currently enrolled students.
- b. Students living within .5 miles of the school.
- c. Students living within District attendance boundaries.
- d. Students living outside District attendance boundaries.

Students who live within the following attendance area, but do not secure enrollment at Edison Elementary School through the random student selection process will default to Cerritos Elementary School as their home school.

The attendance area of this school is that part of the Glendale Unified School District enclosed by the following described line: Starting at the intersection of Ivy Street with the western boundary line of the Glendale Unified School District, the line runs east on the center line of Ivy Street to its intersection with Columbus Avenue: north on the center line of Columbus Avenue to its intersection with

- a. Siblings of currently enrolled students.
- b. Students living within .5 miles of the school.
- c. Student living within the previously established school attendance boundaries.
- d. Students living within District attendance boundaries.
- e. Students living outside District attendance boundaries.

Students who live within the following attendance area, but do not secure enrollment at Franklin Elementary School through the random student selection process will default to Balboa Elementary School as their home school.

The attendance area of this school is that part of the Glendale Unified School District enclosed by the following described line: Starting at the intersection of the Southern Pacific Railway with the western boundary of the Glendale Unified School District, the line runs southeast along the center line of said railway, including both sides of Air Way, to its intersection with the Ventura Freeway;
