2. **Update on Measure S and Facility Programs**

There will be a presentation including an update on the Superintendent's Facility Advisory Committee meeting, a review of the action items on the agenda, as well as a discussion of future items that will be brought to the Board for consideration.

3. **Proposed Use of College View Facilities**

This report will share staff recommendations to utilize space at the College View Facility to house Verdugo Academy, currently located on the Dunsmore Elementary School campus and Jewel City, currently located at the Pacific Avenue Education Center campus. This will allow for the expansion of the Japanese FLAG program at Dunsmore, and to continue the current collaboration between College View and Jewel City students.

3. **Seamless Summer Feeding Option**

The Glendale Unified School District will be participating in the Seamless Summer Feeding Option (SSFO) program for the fourth year this summer. The SSFO program provides free meals during summer vacation to children under the age of 18 and the disabled in low-income areas with at least 50 percent of its children approved for free or reduced price meals under the National School Lunch Program from June 8, 2015 to July 31, 2015.

4. **Development of Trustee Areas**

GUSD elections are governed by the City of Glendale Charter. In order to transition from "atlarge" elections to "by-trustee area" elections, the District placed Measure E on the April 7, 2015 ballot to amend the City Charter. Measure E was rejected by the voters. Subsequently, the District was served a Lawsuit for alleged violation of the California Voting Rights Act (CVRA). An update will be provided on future steps and litigation status.
