## B. COMMUNICATIONS FROM PUBLIC

#### 1. Public Communications

ADDRESSING THE BOARD OF EDUCATION—An individual or group representative may address the Board of Education on any agenda item or subject within its jurisdiction by completing a request card. Speakers are requested to state their <u>name and address</u> prior to speaking to the Board. Not more than <u>five minutes</u> may be allotted to <u>each speaker</u> and no more than <u>twenty minutes</u> to <u>each subject</u>, except by unanimous consent of the Board of Education. Board Members may question the speaker but there will be no debate or decision. The Superintendent may refer the matter to the proper department for review.

#### C. ACKNOWLEDGEMENTS AND RECOGNITIONS

- **a.** Glendale High Dance Team Sweeps USA Nationals The 2014 Glendale High School Dance Team makes history at the USA Nationals by taking first place in all five varsity divisions, and in addition the JV squad also brought home a first place award.
- b. Los Angeles County Office Regional Occupational Program (LACORP) -2014 Student Recognition Five students represented Glendale Unified School District's Regional Occupational Program (ROP) classes in the annual Los Angeles County Office Regional Occupational Program Outstanding Student Recognition Program. Students have demonstrated personal traits such as outstanding character, attitude, leadership, and/or community involvement. Representatives from business and industry interviewed students and evaluated projects in their respective occupational fields.
- **c.** *Bob Hope Airport Authority Tower Banner* The Burbank-Glendale-Pasadena Airport Authority once again offered students from Glendale, Burbank, and Pasadena Unified School Districts the opportunity to submit original artwork for the tower Banner competition, with the winning entries from each school district being displayed on the building façade to offer airport visitors an added dimension to their experience of the airport and aviation. The competition winner this year from Glendale Unified School District is Daniel S. Lee, from Crescenta Valley High School. Other District finalists are Vardui Grigoryan, Clark Magnet High School (2<sup>nd</sup> place), and JJ Junha Yoon, Hoover High School (3<sup>rd</sup> place). As an appreciation for GUSD's participation and for supporting and promoting education programs for the arts, Lucy Burghdorf, Public Relations Manager for the Airport Authority, is presenting the District with \$3,000 to be used in part to award student winners with gift certificates for art supplies. Each participating high school will receive a share of the balance of the donation for support of their Visual Arts program.
- **d.** Congressional Art Competition Crescenta Valley High School students Grace Poole and Madisen Hunt won second and third place, respectively in the 28<sup>th</sup> District Congressional Art Competition for 2014.
- e. *History Day 2014* The Glendale Unified School District would like to recognize Glendale High School students in Mrs. Macaulay's History classes for participating in the Los Angeles County and California State History Day 2014.
- **f.** 20 Schools Make California Business for Education Excellence Honor Roll Balboa, Cerritos, Columbus, Dunsmore, Edison, Fremont, Jefferson, Keppel, Lincoln, Mann, Monte Vista, Mountain Avenue, Valley View, Verdugo Woodlands Elementary Schools, Roosevelt, Rosemont, Toll, Wilson Middle Schools, Clark Magnet and Crescenta Valley High Schools staff and students are among 2,099 schools in the state of California to be recognized by the California Business for Education Excellence for raising student achievement.
- g. US News and World Report ranks Four of Glendale's High Schools Crescenta Valley High School earned a Gold Medal, while Clark Magnet, Glendale High and Hoover High Schools each earned a Silver medals by the US News and World Report ranking of American high schools. Of 19,400 high schools in 50 states, 2,026 were recognized for considerably outperforming their state's standards.
- **h.** California Distinguished School Cerritos, Edison and Muir Elementary Schools have received the California Distinguished School status. The California School Recognition Program identifies and honors that State's most exemplary and inspiring public schools with the California Distinguished School Award.
- i. *Title I Academic Achievement Schools* Cerritos, Edison, Keppel and Mann Elementary Schools were selected as Title I Academic Achievement Schools.
- **j.** Classified Employee Week The week of May 19 23, 2014 will be recognized as Classified Employee Week. Representatives of the California School Employees Association within the district are invited to attend the meeting to be acknowledged on behalf of all District classified employees.
