1. Resignations

The resignations of the employees listed have been accepted by the Assistant Superintendent, Human Resources, as effective and final per Board Policy 4117.2, 4217.2, and 4317.2, and are being reported to the Board of Education for its information.

2. Educator Effectiveness Funding Plan

This report will provide the Board of Education with information regarding the California Department of Education Educator Effectiveness funding entitlements specifically to be used for professional development, coaching, and support services as outlined in Assembly Bill (AB) 104. Based on full-time equivalent (FTE) of certificated staff, the District will receive approximately \$1,852,062.

3. Action by the State Allocation Board Providing for an Increase in the Rate of 17 Developer Fee Assessments

The State Allocation Board (SAB), at its meeting on February 24, 2016, authorized a bi-annual inflationary increase in the statutory fees (Developer Fees) that may be assessed by school districts for residential and commercial development. The new statutory rates (developer fees) are \$3.48 per square foot for residential development (currently \$3.36), and \$0.56 for commercial/industrial construction (currently \$0.51 per square foot).

This report outlines a "next step" plan in conjunction with the District's continued assessment of developer fees on new construction projects.

4. Proposed Revisions to or Retirement of Board Policies Regarding Business and Non-Instructional Operations; Bylaws of the Board; Community Relations; Instruction; Philosophy – Goals – Objectives and Comprehensive Plans; and Student Welfare

This report will provide the Board of Education with information on the need to revise or retire existing Board Policies (BP) relating to Actions by the Board (BP 9323.2); Board Agenda/Meeting Materials (BP 9322); Free and Reduced Price Meals (BP 3553); Independent Study (BP 6158); Married, Pregnant, and Parenting Students (BP 5146); School Based Program Coordination (BP 0420.1); and Uniform Complaint Procedures (BP 1312.3), as recommended by the California School Board Association and to comply with Education Code and federal and state laws.

This report provides the Board of Education with information on the revisions to course offerings for the Glendale Unified School District secondary remedial summer school program for middle and high school students for the summer of 2016.

The Secondary Education Council has reviewed the information and made a recommendation of approval of the course outlines to the Board of Education.

8. Commencement and Promotion Exercises 2016

Each year, the Board of Education and District Administrators are invited to attend the promotion ceremony at the middle schools and the graduation ceremony at the high schools. Members of the Glendale Community College Board of Trustees have been invited to attend the graduation ceremony at our high schools as well. This report provides the names of those who will be attending the commencement and promotion exercises at the middle and high schools.
