

GORE SCHOOLS TECHNOLOGY EQUIPMENT USE AGREEMENT 2020-2021

Parent/Guardian,

Please read, sign, and return this form to the site secretary ASAP so we may plan Chromebook distribution to all students needing one. You have a choice to not allow home transportation of Chromebook. If we turn out for weather or COVID issues, your student will need a device to access Distance Learning lessons and assignments. We understand that you may not be comfortable with your student being responsible for the care of a Chromebook outside the classroom. You have a choice on transporting these devices to home and school. Please let us know if you accept the responsibility of having your student take a Chromebook off campus. They will need to have it daily in class so transportation of the device to and from school daily is essential, or leave it at school.

All students will have access to a chrome book or other device that will access the internet for on-campus learning. These devices will be the main delivery platform used in every classroom at Gore Schools for delivering lessons and for students to return assignments to the teacher. Parents have the option to allow their student to take this device off campus after school hours. If the district moves to Distance Learning, students will need a device that connects to the internet to access lessons and turn in classroom work from home.

Student/Parent Technology Access Agreement

1. There is no cost to the parent for a Chromebook or hot spot. Any cost that may be incurred will be the result of your student's abuse or damage to a device.
2. Like a textbook, a Chromebook will be issued to every student for on campus use, if they do not have their own personal device for internet access. Students will be responsible for the use and care of the device (s), just as they are responsible for a textbook or other school equipment. Student/parent will be responsible to reimburse the district for any lost, stolen, or damaged school equipment. Chromebooks cost \$300.00 each. A student will not be issued a replacement device if they lose or damage theirs until this cost is repaid to the district, in full. Any damage caused to a device must be repaired and the cost covered by the parent. The full replacement cost (\$300.00) must be paid before a replacement device can be issued while awaiting repairs on a damaged device. The balance, after the repair cost, will be reimbursed back to the parent.
3. Hot spots for WIFI replacement cost is \$60.00 per device. The same procedure will be followed for all devices on repair/replacement. Contact building principal for hot spot availability and check out.
4. Students WHO do not have a signed agreement will not be allowed to take devices off campus but will have access to a device while on campus, in their classrooms.
5. School issued equipment will be used for school instructional purposes only. Any use not authorized by GPS may result in the forfeiture of the device(s) and user privileges. Parents are responsible for internet content access. GPS shall adhere to all CIPA (Child Internet Protection Act) mandates. Any suspected violations of CIPA shall be reported to GPS immediately.
