March 1, 2025

### TAX LEVY LIMIT

On or before March 1, 2025, school districts shall submit to the State Comptroller, the Commissioner of Education and the Commissioner of Taxation and Finance, in a form and manner prescribed by the State Comptroller, any information necessary for calculation of the tax levy limit.

April 1- April 5, 2025

### LEGAL NOTICE

First legal notice must be advertised a minimum of 45 days prior to uniform vote day (May 20, 2025). Annual meeting date and vote date are the same. Publication occurs 4 times within the seven weeks prior to the annual meeting and vote date of May 20, 2025 or a minimum of 45 days prior to the vote, in 2 newspapers having general circulation within the District.

# RECEIPT OF EARLY MAIL AND ABSENTEE BALLOT

# **APPLICATION** (Districts with Personal Registration)

No earlier than 30 days prior to the election – April 21, 2025 (actual 30th day is April 20th, a Sunday. General Constr. Law states next regular business day should be used) and no later than May 13, 2025 (minimum of 7 days before the election) if application requests that early mail or absentee ballot be mailed, and no later than May 19, 2025 (minimum of 1 day before the election) if applicant or agent delivers the application to District Clerk in person

**April 21, 2025** 

### NOMINATION PETITIONS DUE

30 days prior to election (actual 30th day is April 20th, a Sunday. General Constr. Law states next regular business day should be used).

**April 21, 2025** 

#### VOTER PROPOSITION

By April 21, 2025 - Must be submitted 30 days prior to vote (unless otherwise specified by Board rule or a law governing the subject matter of the proposition) (Education Law § 2035[2]). (actual 30th day is April 20, 2025, a Sunday. General Constr. Law states next regular business day should be used). If the Board has adopted a rule requiring a proposition to be submitted in time to permit notice of the proposition to be included with the Notice of Budget Hearing, Budget Vote and Election, the district may use a date 60 days in advance, such asMarch 21, 2025, as the due date.

# DETERMINATION OF CANDIDATES, REFERENDA AND PROPOSITIONS

BEFORE DISTRIBUTION OF MILITARY BALLOTS.

**Deadline for filing nominating petitions names of all candidates for public office.** Also deadline for amendments, referenda, propositions and questions to be voted on for such ballots.

# MILITARY VOTER REGISTRATION APPLICATION DUE (Districts with Personal

Registration)

Military votes must be registered no later than 5:00 pm April 24, 2024 in order to be issued a ballot for the 2025 budget vote and election.



**April 25, 2025** 

#### **DISTRIBUTE MILITARY BALLOTS**

Ballots for military voters shall be mailed or otherwise distributed in accordance with the preferred method of transmission on the military ballot application, as soon as practicable but not later than 25 days before the election or by April 20, 2025.

**April 28, 2025** 

### PROPERTY TAX REPORT CARD AND SCHOOL DISTRICT REPORT CARD

Property Tax Report Card must be submitted to SED by the close of business the day after the Board adopts the budget and the Property Tax Report card. The Property Tax Report Card must be submitted no later than 24 days prior to the budget vote no later than April 28, 2025. The Report Cards are required by Education Law and Commissioner's Regulation to be made available to the public by all of the following methods:

- 1. Transmitting them to newspapers having general circulation in the district;
- 2. Appending them to copies of the proposed budget made publicly available as required by law; and
- 3. Having copies available for distribution at the annual meeting on May 20, 2025.

In addition the property tax report card must contain the following additional information.

- a. A schedule of reserve funds, setting forth the name of each reserve fund, and a description of its purpose.
- b. Balance as of the close of the third quarter of the current school district fiscal year.
- c. A brief statement explaining any plans for the use of each such reserve funds for the ensuing fiscal year.

April 30, 2025

### BUDGET AVAILABLE

Making budget available depends on date of Budget Hearing - 7 days prior to the Budget Hearing is April 30, 2025. Budget Hearing date is May 7, 2025. In addition, the budget will be made available to residents of the district upon request and at school district offices, any public library within the district and on the district's website. The budget must also be available at the polling place on the date of the vote on May 20, 2025.

May 6 to May 15, 2025

### LAST VOTER REGISTRATION DAY

Any day from May 6 through May 15, 2025. Last day may not be more than 14 nor less than 5 days preceding the annual meeting or election as determined by the Board of Education.

May 7 to May 14,2025

### MAIL SCHOOL BUDGET NOTICE TO ALL QUALIFIED VOTERS

The School Budget notice must be mailed any date after the date of the budget hearing but no later than six (6) days prior to the annual meeting and election. The last date to mail the School Budget Notice to qualified voters is May 14, 2025. Notice must be in English and Spanish.

May 13, 2025

RECEIPT OF EARLY MAIL AND ABSENTEE BALLOT APPLICATIONS AND DELIVERY OF EARLY MAIL AND ABSENTEE BALLOTS (Districts without Personal Registration i.e., Poll Registration).

Minimum of 7 days before the election if ballot to be mailed to voter and May 19, 2025 – (minimum of 1 day before the vote) if ballot to be personally delivered to voter.



# **AGENT (Districts with Personal Registration)**

No later than 6 days before the election, May 14th, 2025, the District Clerk shall mail, by regular mail, an early mail or absentee ballot to each qualified applicant who has applied before such day and who has requested that such early mail or absentee ballot be mailed to him or her at the address set forth in his or her application. If the application is delivered in person by applicant or agent later than May 13, 2025 (7 days prior to the election) but not later than May 1, 2025 (1 day before the election) the District Clerk shall deliver such early mail or absentee ballots (for those applicants whom the District Clerk determines are qualified to make such applications and receive such ballots) to such applicants or the agents named in the application when such applicants or agents appear in the District Clerk's office.

May 15, 2025 MAKE AVAILABLE LIST OF MILITARY VOTERS

No date stipulated but make available list of military voters to whom military ballots

were issued.

May 15, 2025 MAKE AVAILABLE LIST OF PERSONS TO WHOM EARLY MAIL AND

ABSENTEE BALLOTS ISSUED

No date stipulated but should probably be done at least 5 days prior to election.

May 15,2025 **VOTER REGISTER AVAILABLE** 

May 15, 2025 or 5 days prior to election.

May 20, 2025 **VOTE AND ELECTION** 

Third Tuesday in May

May 20, 2025 THE ANNUAL MEETING DATE

This is the same as the date of the budget vote and election.

May 20, 2025 BOARD OF REGISTRATION

Meets during the election to register persons for 202 6 annual meeting (i.e., 2026

budget vote and election) and special district meetings.

June 17, 2025 **BUDGET REVOTE DATE** 

Revote must be held on the third Tuesday in June
