

## RULES FOR TORC - CSE

### Yes

A choice of **Yes** in the **TORC** field is representative of a student whose program or related service occurs in a setting outside of general education.

Examples:

- When a student attends a non-integrated special class program
- When a student is pulled out of a general education class to receive a non-integrated related service, such as Speech/Language, Occupational Therapy, etc.

### No

A choice of **No** in the **TORC** field is representative of a student whose program or related service occurs in a setting with general education peers.

Examples:

- When a student receives academic support by a special education teacher within a general education integrated classroom
- When a student receives consultant teacher services within the general education classroom
- When a student receives the services of a teacher assistant (paraprofessional, aide, etc.) in the general education setting
- In a rare occurrence, when a student is pulled out of a non-integrated special education setting to receive a related service, such as Speech/Language or Counseling in an integrated setting. (In this instance the related service time must be subtracted from the time allocated to the non-integrated special education program.)

### N/A

A choice of **N/A** in the **TORC** field is representative of a student whose service is being delivered concurrently with the student's non-integrated special education program.

Examples:

- When a student receives the services of a teacher assistant (paraprofessional, aide, etc.) in a non-integrated setting
- When a student is pulled out of a non-integrated special education program to receive non-integrated services such as Speech/Language, Occupational Therapy, etc.
- When a student receives a push-in related service within a non-integrated setting

**Note:** To avoid duplication within the TORC calculation, Aide/Paraprofessional/Teacher Assistant time has to be listed twice within the **Related Service** column of the Related Services section, if those services are split between integrated and non-integrated settings. This is similar to the way direct and indirect consultant teacher services are entered.

## TORC TIPS

### PROGRAMS

- TORC is **NO** for any Consultant Teacher services, if the services are provided to the student within the general education setting. Indirect Consultant Teacher services are always **NO**.
- TORC is **NO** for programs if the students are not pulled out of the general education setting for these programs; the program is provided within the general education setting (i.e. Resource, Special Class within the classroom).
- TORC is **YES** for programs if the students are pulled out of the general education setting for these programs (i.e. Resource, Special Class).
- **BOCES or Private Placements:** TORC is **YES** if the student is enrolled in a full-time BOCES program in a school where there are non-disabled students.

### RELATED SERVICES

- TORC is **NO** if the student receives the related services in the general education setting with non-disabled students.
- TORC is **YES** for related services (speech, OT, PT, etc.) if they are pull out of the general education setting for these services.
- TORC in **N/A** for related services delivered to students in a self-contained special education program.
- TORC is **NO** for a student with a 1:1 (or shared) aide provided in the general education setting.
- TORC is **N/A** for a student with a 1:1 (or shared) aide in a self-contained program.
  - *(\*NOTE: TORC for an aide is never YES)*
- TORC is **N/A** for related services delivered to students in a BOCES program as per above.
- TORC field **will not** appear if a student in enrolled in a school where there are special education students only (segregated Settings).
