Mr. Brennan called the meeting to order at 6:20 p.m.

EXECUTIVE SESSION

Upon motion duly made by Mr. Schoer, seconded by Mr. Toles, and carried (6-0), the Board moved into Executive Session at 6:21 p.m. for the purpose of litigation and personnel contract review. Mr. Giuliano entered the meeting at 6:43 p.m.

Upon motion duly made by Mrs. Boba, seconded by Mr. Mastroianni, and carried unanimously, the Board returned to the regular meeting at 7:45 p.m. Mr. Brennan led the audience in the Pledge of Allegiance and instructed those in attendance where to exit the building in case of an emergency. He asked those present to silence cell phones and beepers.

COMMUNITY FORUM

Mr. Brennan thanked everyone for attending this very important meeting. Mr. Carasiti stated that it is very important for the community to be heard and to hear what is going on and to listen to the ramifications of what we are doing and why we are doing it. Mr. Carasiti discussed a roll over budget which would mean a tax rate increase of 8.48%. He continued that a contingency budget would mean a tax rate increase of 6.8%. Under a contingency budget, expenditures that do not constitute ordinary contingent expenses such as the purchase of new equipment, the use of public school buildings and grounds, except where there is no cost to the district, capital expenditures, except in emergencies, are not permitted. Mr. Carasiti went on to say that as a result of the March 7 budget meeting the Board felt that we should aim for a tax rate between 3% and 3.5%. In order to get to that, we would have to take an additional \$700,000 out of the budget which was submitted on March 7 containing cuts in the amount of \$2.530.192. He continued that as per the direction of the Board he has come up with an additional \$456,600 in cuts. Mr. Carasiti further stated that this is below the \$700,000 which the Board requested, but this is as far as we can responsibly go. These cuts include classroom teaching assistants at HHS, school-to-career program at HHS, music program (lessons) district, BOCES cultural arts program, and administrative reorganization at the district level. The administrative reorganization would include sharing a personnel administrator with Elwood and there would no longer be an Executive Director of special Education; however, there would be a Director of Special Education. Mr. Schoer stated that these are the recommendations of the Superintendent but that this does not mean it will be the decision of the Board. Mr. Toles stated that he felt the student assistance program is necessary. Mrs. Boba echoed those sentiments. Mrs. Boba stated that all these cuts are very painful and that all Board members are aware of that. Mr. Giuliano asked if the gifted and talented program would be completely eliminated. Mr. Carasiti stated that the program would be totally eliminated. Mr. Carasiti stated that with regard to the cultural arts program at BOCES it is a two year program and students who are currently enrolled would be allowed to complete the second year. Mr. Mastroianni stated that he has three children in the district and considers their education to be a bargain. We are in a position that we need to put up a budget that needs to be supported by the entire community.

PUBLIC PARTICIPATION

At this time Mr. Brennan opened the floor for questions and statements from residents of the district. Many residents stated that they were unhappy about the cuts especially the SAIL program, the music program, the BOCES cultural arts program, and the science research program. Some residents felt that the district is spending too much money in schools and stated that we need to look to teachers and administrators to pay more of their benefits. Another resident expressed disappointment regarding the Executive Director of Pupil Personnel and stated that she did not understand the change in title. Mr. Carasiti assured her that there would be no loss in personnel. Some residents felt that the primary responsibility of the district is education and that sports are secondary. Mr. Mastroianni responded that colleges look at the entire picture and we need to provide all these options.

A resident stated that he moved in to this district three years ago for its educational quality and asked how the Board reached these budget reductions. Mr. Mastroianni advised that the Board has not adopted a budget at this time. Mr. Toles stated that we do not have the resources in this district. Mr. Schoer advised that there is a reduction of \$800,000 in revenue. He continued that we have to think ahead and have to think about all of our students. We wish we did not have to cut anything. Mr. Brennan informed residents that if the MTA payroll tax goes through it will cost the district an additional \$107,000. We need to make hard decisions. Mr. Giuliano stated that there will be an increase in pension contributions.

At this time Mr. Mastroianni presented three scenarios and asked by show of hands which one of these scenarios those present felt the entire community would support. The first was a current services rollover budget which would be an 8.48% tax rate increase that would amount to approximately \$656.00 a year on a house assessed at \$4,000. The second scenario would be a contingency budget which would be a 6.8% tax rate increase which would amount to approximately \$524.00 per year on a house

assessed at \$4,000. The last scenario would be a 4.37% tax rate increase which would amount to \$338.00 per year on a house assessed at \$4,000. This last scenario includes the additional cuts. The Town of Huntington uses \$4,000 as the average assessment on a home located in the Harborfields School District. It was noted that many homes are assessed higher than \$4,000. It was the consensus of those present at the meeting that the 4.37% would be supported by the entire community.

The Board took a 10 minute recess at 9:45 p.m. and resumed the meeting at 9:55 p.m.

SUPERINTENDENT'S REPORTS

New Age Therapy, Inc. to provide therapy appropriate to the mental ability and physical condition of the students in accordance with the Commissioner's regulations and the individualized education program (IEPs) for the period July 1, 2008 through June 30, 2009. The rates for services are \$30.00 per child per half hour scheduled on-site session, \$60,00 per child per half hour scheduled off-site session and \$100.00 per evaluation and \$50.00 per screening.

Whereas, amendments to the Omni Financial Group (OMNI) Section 403(b) IRC Third Party Administrator Services Agreement have been negotiated by the Eastern Suffolk BOCES for the benefit of its component school districts; and

Whereas, it is deemed to be in the best interest of the District to make such amendments to said Agreement;

Now, therefore, be it resolved, that the Board President is hereby authorized to execute an amended Administrative Services Agreement with OMNI, as presented to the Board at this meeting; and

Be it further resolved, that the Administrative Services Agreement with OMNI dated May 13, 2008 shall be rescinded when the amended Agreement is fully executed.

4.9 <u>Joint Municipal Cooperative Bidding with</u> Western Suffolk BOCES

Upon motion duly made by Mr. Schoer, seconded by Mr. Toles, and carried unanimously, the following resolution was approved. Mr. Schoer congratulated administration stating that this was one of the ways to share services with other school districts.

Whereas, the Participant is a municipality within the meaning of General Municipal Law §119-n and is eligible to participate in the Board of Cooperative Educational Services, Second Supervisory District of Suffolk County (hereinafter Western Suffolk BOCES) Joint Municipal Cooperative Bidding Program (hereinafter the "Program") in the areas mentioned above; and

Whereas, with respect to all activities conducted by the Program, the Participant wishes to delegate to Western Suffolk BOCES the responsibility for drafting of specifications, advertising for bids/proposals, accepting and opening bids/proposals, tabulating bids/proposals, awarding the bids/proposals, and reporting the results to the Participant.

Be it resolved, that the Participant hereby appoints Western Suffolk BOCES to represent it and to act as the lead agent in all matters related to the services as described above; and

Be it further resolved, that the Participant hereby authorizes Western Suffolk BOCES to place all legal advertisements for any required cooperative bidding in Newsday, which is designated as the official newspaper for Western Suffolk BOCES; and

Be it further resolved, that this Agreement with the Participant shall be for a term of one (1) year as authorized by General Municipal Law §119-o.2.j.

Members of the PTA as well as Senator Marcellino, and Assemblymen Raia and Conte also attended this breakfast. Mr. Giuliano advised that the advice from our legislators is to try not to spend money. Senator Marcellino talked about what money would be available to the district. There was not a lot of good news.

NYSSBA State Legislative Network, March 1-3, 2009 in Albany, NY

Mr. Brennan and Mr. Schoer attended the SLN in Albany on March 1 and 2. Mr. Brennan stated that he and Mr. Schoer met with Malcolm Smith, New York State Senate Democratic Majority Leader and Comptroller DiNapoli and also visited with local legislators. Mr. Schoer reported that it was a very insightful two days. New York's economy is not good. Pension costs will be going up because of what is happening in the stock market. We need to share services for greater efficiency. He continued that he and Mr. Brennan were primarily there to lobby. One of the areas of discussion was an addition of a Tier V to the employees' retirement system. They also lobbied for WICKS reform and to try to avoid the MTA Tax.
