Mr. Mastroianni called the meeting to order at 6:10 p.m.

EXECUTIVE SESSION

Upon motion duly made by Dr. McDonagh, seconded by Mr. Toles, and carried (6-0), the Board moved to executive session for the purpose of employment history of a former employee of the district, personnel and contractual issues, and a legal matter.

Student Representative's Report

Both the girls' and boys' basketball teams won the county but lost the championship. Kelsey Margey came in 2nd at the nationals in running. Andrew Colamussi came in 3rd in the county in wrestling. Spring sports will start next week.

YMCA Before & After School Childcare Program Presentation

Eileen Knauer, Executive Director of the YMCA reported on their before and afterschool childcare program. She stated it is more a recreation based program. The Board asked for some additional information and as soon as the YMCA provides the information a decision would be made.

Energy Performance Contract Report

Fred Seeba of BBS, discussed the energy performance contract with Johnson Controls. He stated that BBS feels that the Board should move forward and enter into a contract with Johnson Controls as soon as possible. The work would start in the fall depending on how quickly it gets through SED.

ITEMS FOR DISCUSSION

HACEF Summer Camp

Mr. Carasiti advised the Board that HACEF is proposing a summer enrichmentacademic camp to be offered to Harborfields' students. This will be modeled after the Booster Club camp. It was the **consensus** of the Board to move forward with this program.

2010-2011 Proposed Budget

Mr. Carasiti advised that things have not improved regarding state aid. He continued that we understand that the community faces financial problems. The Board and administration must put a budget together for our students that maintains the quality of education we have in Harborfields. We are cutting 14 members of the teaching staff and 10 teaching assistants. Custodial and clerical positions will also be affected. Class size will not be affected. Most programs have been maintained in this budget. The library staff will be reduced by 50% and the psychology staff from 7 to 6 staff members. The tax rate is now approximately 3.5%. A contingency budget would dismantle many of our programs.

Mr. Carasiti then discussed placing a transportation proposition on the ballot raising the mileage limits for TJL and OMS from the current ½ mile to 1 mile and from the current 1 mile at HHS to 1 ½ miles at HHS. After discussion by the Board it was decided that the current mileage limits would remain in effect at this time.

BOARD OF EDUCATION ACTIVITIES

There were no Board of Education activities at this time.

PUBLIC PARTICIPATION

A resident stated that she is glad that the district is looking into energy efficiency and asked what the annual cost would be to the district. Mr. Nimmo advised that the cost of the project is \$4.4 million.

A resident stated that she understood that we are losing second teams and asked if the Board would consider bringing intramurals back. She continued that we can make it work. Busing is not an issue as many parents can car pool.

EXECUTIVE SESSION

Upon motion duly made by Mr. Giuliano, seconded by Mr. Schoer, and carried unanimously, the Board moved to executive session at 10:15 p.m. to discuss contracts of certain district employees.

Upon motion duly made by Mr. Banks, seconded by Mrs. Boba, and carried unanimously, the Board returned to the regular meeting at 10:54 p.m.
