Mr. Mastroianni called the meeting to order at 6:05 p.m.

EXECUTIVE SESSION

Upon motion duly made by Mr. Schoer, seconded by Mr. Giuliano, and carried (5-0), the Board moved to Executive Session at 6:06 p.m. for the purpose of collective negotiations, employment history of a particular individual, and for the purpose of matters involving the Family Educational Right to Privacy Act. Ms. Melone left the meeting at 6:50 p.m.

Mrs. Boba entered the meeting at 7:32 p.m. Mr. Toles entered the meeting at 7:36 p.m.

Upon motion duly made by Mr. Toles, seconded by Mr. Schoer, and carried unanimously, the Board returned to the regular meeting at 7:49 p.m.

Mr. Mastroianni led the audience in the Pledge of Allegiance and instructed those in attendance where to exit the building in case of an emergency. He also asked that all cell phones and beepers be silenced during the meeting.

PUBLIC PARTICIPATION

There was no public participation at this time.

ANNOUNCEMENTS

School Board Recognition Week was celebrated at this meeting. The SEPTA copresidents presented the Board with an inscribed tray thanking the Board for all their dedication and hard work. SEPTA also provided refreshments for the Board and community at this meeting.

SUPERINTENDENT'S REPORTS

Student Representative's Report

Alex Boccard, student representative at Harborfields High School, made the following report:

- ➤ Boys' Cross Country won the counties for the first time in history
- Girls' Volleyball team lost the first round of the playoffs
- ➤ The first high school student leadership council meeting "Compassion without Borders" was a success
- Dodging cancer was successful students raised over \$500
- Senior Butler will take place next week
- ➤ Winter Pep Rally will be held December 18. Spirit Week will be held December 14-18.

Superintendent's Report

Mr. Carasiti advised the Board that efforts have been made with the Suffolk County Department of Health by both himself and Dr. Geffken to change the hours of vaccination clinic for the H1N1 virus from 1:00 p.m. - 5:00 p.m. to 3:00 p.m. - 7:00 p.m. Mr. Carasiti stated it was a safety issue to have people coming into our building when school is in session. Dr. Geffken advised that he is attempting to have the time changed but the Department of Health is not being cooperative at this time. Dr. Geffken also advised that the vaccine will be given to targeted people as follows:

- Children 6 months to 24 years of age
- persons 25-64 with chronic health conditions
- caretakers of infants under 6 months of age
- pregnant women
- healthcare and emergency health personnel

Dr. Geffken continued that all students must be accompanied by a parent or guardian before the vaccine will be administered. The vaccination will be administered on Monday, November 30 at Harborfields High school in the multipurpose room.

Overview of Oldfield Middle School's Support Programs

Mr. Cronk, Ms. Allen, and OMS guidance staff reported on the support programs at OMS including TLC (Tornadoes Listening and Caring), peer mediation, teaming, student of the month, crisis intervention, and bullying.

Overview of Board of Education: Drug & Alcohol Abuse Survey

Mr. Valente, Dr. Bennardo, and Mr. Lasinski discussed a list of things that the district is currently doing such as PTSA Safe Homes Program, Residential Treatment Center Drug Presentation, grade level drug and alcohol assemblies, great American smoke out, Officer Wendy Police Smart program, Annual 11th and 12th Grade DWI Assembly, along with other programs. Some new ideas that Mr. Valente and Dr. Bennardo would like

added to this are: Health Talk in *The Clarion* and Athletes Helping Athletes Round Tables. On December 1, 2009 a presentation will be held at the high school at 7 p.m. on Drug Addiction and the Adolescent.

At 9:30 p.m. the Board took a short recess in order to enjoy the refreshments that SEPTA provided in honor of Board Recognition Week. The meeting resume at 9:40 p.m.

PUBLIC PARTICIPATION

A resident asked if there are ways to generate revenue from corporate sponsorship. Mr. Carasiti advised that there are many legal issues regarding corporate sponsorship.

A resident advised the Board that children are not being engaged in the intramural programs and asked how long it would take to access the validity of these programs. Mr. Mastroianni asked for an update regarding this situation.

A resident asked that the Board reconsider second teams when they are preparing next year's budget.

A resident stated that the Town of Huntington will be voting on councilmanic districts on December 22, 2009. She continued that if this item is approved it will mean more politicians which will drive up the cost to the taxpayer. She further stated that the district has enough hurdles to encounter without taxes being driven up because of this issue.
