Whereas, the Board for reasons of economy and efficiency, has determined that it is appropriate to abolish and to create certain pedagogical positions in the District:

The Board hereby abolishes the following positions, effective close of business on June 30, 2012:

- ➤ 1.0 FTE middle school assistant principal tenure area position
- ➤ 1.0 FTE elementary school assistant principal tenure area position

Further, that the Superintendent of Schools is hereby directed to provide written notice to those employees whose employment is discontinued as a result of the abolition of the above-listed positions, as set forth in a Memorandum to the Board from the Superintendent of Schools, dated June 27, 2012, as presented at this meeting, in accordance with the provisions of Section 3103 of the Education Law, Part 30 of the Regents Rules and/or the terms of any applicable collectively Negotiated Agreement, termination of their employment effective close of business on June 30, 2012; and

Further that said employees who are not entitled to Part 30 bumping rights shall be notified, in writing, of their placement on a preferred eligible list in the tenure area(s) of their employment regarding their statutory recall rights and/or their recall rights under any applicable Collectively Negotiated Agreement.

#### Creation of Position – Certificated Employees:

Further, upon the recommendation of the Superintendent of Schools, effective July 1, 2012, the following professional position in the Harborfields Central School District be created in the following area of classification
