Superintendent's Report

Ms. Todaro announced that Harborfields High School received a gold medal in the *US News & World Report's* Best High Schools competition. This recognition earned Harborfields High School a second-place ranking in Suffolk County, 7th on Long Island and 46th in New York State.

Ms. Todaro reported that the 2013-2014 proposed budget was adopted by the Board at the April 17, 2013 meeting. She stated that the budget stays within the allowable tax levy cap of 3.18% and retains programs, class size, and adds a 0.2 STEM program at the high school. She reminded everyone that the Budget Hearing/Regular Meeting

would be held on May 14, 2013 and the Budget Vote will take place on May 21, 2013 from 2:00 p.m. to 9:00 p.m.

Ms. Todaro reported that the district's security practices have been reviewed through two separate security assessments, and she will be presenting a recommendation to the Board of Education, which will be presented to the public at a future meeting.
