Summer Work

- □ A letter was mailed to all 9 12 students informing them of their counselor for the 2016-2017 school year.
- ☐ In order to ensure that the guidance staff was available throughout the summer, at least one counselor was present to staff the office daily, which resulted in more efficient communication with parents and students.

HHS Summer Essay Writing Program

- ☐ In response to the increasing number of students who are applying Early Action/Decision to college, a new program was developed to assist students in starting the college essay writing process during the summer.
- □ 62 seniors participated in a two-week intensive program, giving very positive feedback.

All students have met with their counselors at least twice during the opening months of school.

Enhancing Communication with Parents

- As a result of increased communication, we have seen a rise in attendance at our evening and weekend programs. We had over 100 parents at our Naviance workshop October 20, 2016
- All juniors have had individual conferences with their counselor and a parent or guardian to start planning for their post-graduation options.



The College Process: Applications and Acceptances



College Applications and Acceptances

- ☐ This year, 162 of our 285 seniors have already applied to colleges.
- ☐ The Guidance Office processed 2,577 applications in 2015-16.
- In 2015-16, 285 students out of 305 applied to college, which represents 93.4 percent of seniors.
- On average each senior applied to 9 schools.
- ☐ The Guidance Department welcomed <u>243 colleges and universities</u> in 2015-16
