- 1. You may submit your substitute application by leaving a copy at the High School Main Office addressed to the attention of Jeffrey Evener, Assistant Superintendent for Instruction. You may also submit an electronic copy via email to the attention of Lisa Miner, Office of Instruction Secretary at Iminer@homercentral.org. Once your application has been received and reviewed, Lisa Miner will contact you to set up an interview.
