Facilitator Address	Pete Galloway said most of the current LPC members were selected a couple of years ago. That term continues through June 2023. During the 4-year LPC period, things can change for a district. Any time there is a change to the District Facilities Plan, there is an amendment process to follow. The School Board determined there was a need and asked Kentucky Department of Education for permission to reconvene the committee. Fiscal agents have shared what the district owes and the funding that is available. Sherman Carter Barnhart architects examined the facilities and came back with a draft that was reviewed by the committee tonight
