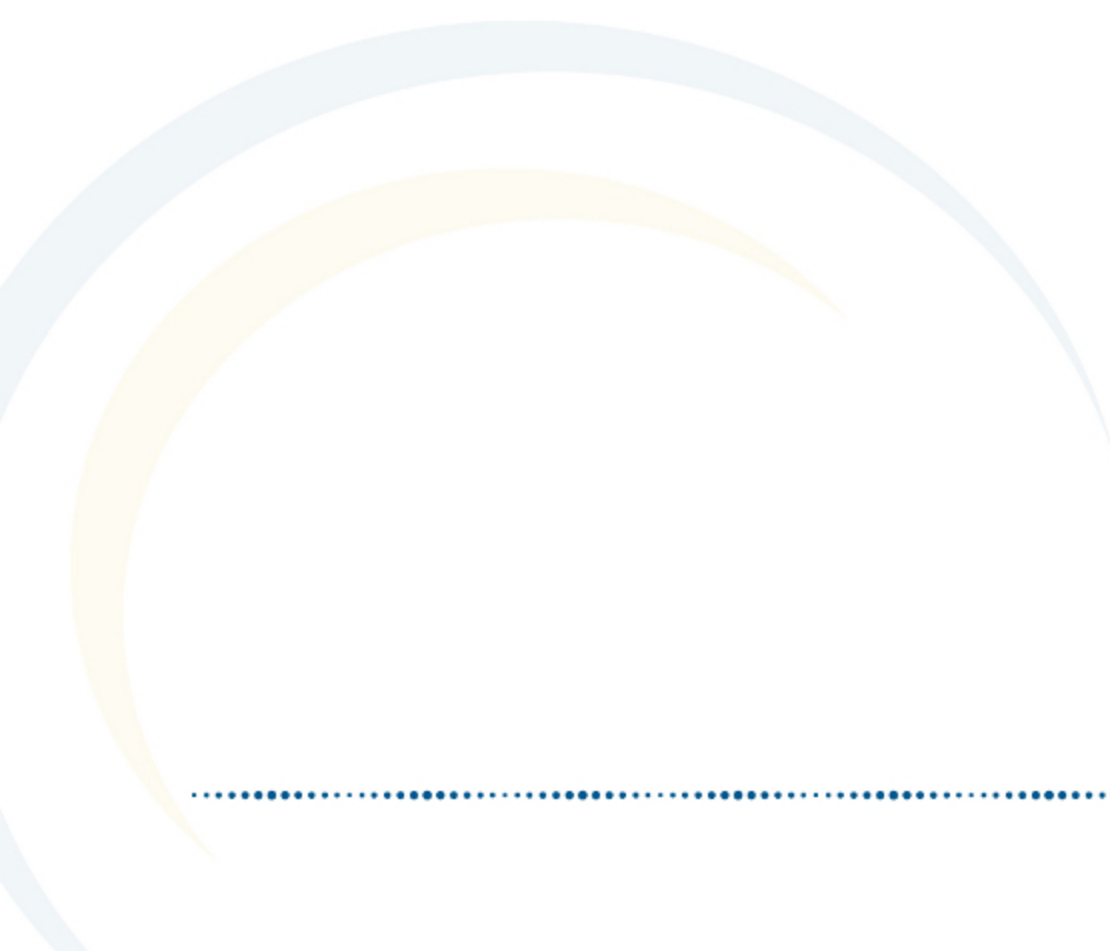

Behavior Incident Management Enhancement

Overview

The following enhancements and updates were made in support of the Behavior Incident Management Enhancement, which transitions recording behavior from a student-centric model to an incident-centric one. This article summarizes all changes made for this enhancement, including all state-specific changes.

The following changes were made to core areas of Campus. Tools are linked to articles describing them where applicable.

Primary [Behavior](#) Tools

- [Behavior Referral](#) - This tool was expanded to support incident-based reporting to include Incident Information and Event and Participant details. Referrals are submitted to the Management Tool when complete and a notification will be sent to the Process Inbox of the selected users.
- [Behavior Management Tool](#) - This tool was added to the [Behavior](#) module for processing submitted referrals and adding additional information as needed. Like the referral, viewing an incident in this tool includes Incident Information and Event and Participant details, but users have the additional option of Adding Resolutions to participants in each event.
- [Student Behavior Tab](#) - This tab has become a largely read-only view of student behavior information, suitable for use in parent conferences. Only information for the student being viewed will be available, not information for other participants. Resolutions can be assigned to the student in this tab and additional printing options have been added for viewing student data.
- [Admin](#) - The behavior Admin tools were moved out of System Administration and into the Admin folder of the Behavior module.
- [Event and Resolution Types](#) - The [Merge Tool](#) was added for merging duplicate types, as well as the [Show History](#) print option for viewing how and when types were merged. Additional Subtypes were also added to the Resolution Type for recording resolutions of Suspension and Expulsion.
- [Preferences](#) - This tool was added for determining what participant information can be displayed in behavior reports and default users to notify when a referral is submitted.
- [Reports](#) - Both the [Event Report](#) and the [Resolution Report](#) were updated with additional report options.
- [Tool Rights](#) - Updated to reflect the new behavior tools.

Secondary Behavior Tools

- **Ad Hoc Reporting** - The Ad hoc Filter Designer's Query Wizard has been updated to include the new behavior-related fields found in the Behavior Management tool. See the [Behavior Filter Fields for Ad hoc Reporting](#) article for a complete list of the new fields within the behavior node.
- **Behavior Letter Wizard** - This tool was updated to use the new behavior tools for triggering behavior letters. Minor wording changes have been made on the editor to match the wording used when recording a behavior incident.
- **Data Analysis** - The Ad hoc Reporting Data Analysis tool has been updated to include new behavior fields under the Behavior node. See [Data Analysis Behavior Fields](#) for a complete list of the new fields.
- **DIS** - For state-linked districts, data will only sync from district to state under the following conditions:
 - An Incident with a state event code mapping.
 - An Incident with a state resolution code mapping.
 - An Incident with a state code mapping and no participant.
 - For BIE only:
 - An Incident with a BIE event code mapping.
 - An Incident with a BIE resolution code mapping.
 - For Maine only:
 - Syncing will only occur if both the event and resolution have a state code mapping.
 - For DIS Batch Sync, Behavior has been added to the +/- 1 year scope.
- **Mobile Referral** - Updated to allow for easy entry of incident referrals.
- **Portal** - The Behavior tab of the Portal has been updated.
- **Process Inbox** - Updated the Behavior Process Inbox message to include with a summary of the incident and a link to the Management Tool for that particular incident. When resolutions are added to an incident, a message will also be sent to the user selected in the Submitted By field.
- **Records Transfer** - When releasing a student's document for records transfer, the print all year report will now be generated and sent as part of the behavior package.

Conversion

With the release of this enhancement, incident records will be created for existing events for state reporting purposes. An incident will be created for each event; users will not be able to modify this organization, but this conversion will not hinder reporting existing event data.

Additionally, CalendarIDs will be assigned to events that do not already have them, based on the timestamp of the event and the enrollment of the first student participant assigned to the event.
