Dear Parents:

**RE: Voluntary Student Accident Insurance – 2019-2020 School Year**

The Huntington Beach City School District does not carry medical or dental insurance for students injured on school premises, while under school jurisdiction, or while participating in school district activities. For these reasons, the school district has arranged a student accident insurance program for your review and consideration. This insurance program is optional and complies with California Education Code, which permits distribution of necessary information from the company providing the coverage.

The following types of student accident insurance plans are available through Student Insurance

- 1) **School-Time Accident Plan:** Covers injuries caused by accidents occurring: (1) at school during the school day; (2) while participating in school sponsored and supervised activities; and (3) during the direct and uninterrupted travel to and from residence and school for regular attendance.  
**COST: Low Option - \$15                      Mid Option - \$28                      High Option - \$43**
- 2) **24-Hour Plan:** Covers injuries caused by accidents occurring anytime (24 hours a day) anywhere in the world. Coverage also includes participation in certain organized sports.  
**COST: Low Option - \$83                      Mid Option - \$108                      High Option - \$210**
- 3) **24-Hour Dental:** Covers injuries to teeth caused by accidents occurring 24 hours a day, can be purchased separately or with other coverage.

The application process is completed online and will allow parents to safely and securely transmit applications through one of the following methods:

**Direct Online Submission:** At [www.studentinsuranceusa.com](http://www.studentinsuranceusa.com), you can complete your Student Accident Insurance application directly on their website. The applications for insurance will be effective immediately and a policy number and insurance card will be available right away. Their system is equipped to accept credit, debit and e-checks for parents' convenience.

**Web "download":** Through their secure web portal you can fill out and print your application directly from the website. Parents sending certified funds will continue to have the option to do so. Student Insurance will need to receive the hard copy application and cashier's check or money order in their office in order for the policy to be effective. The applications for insurance will be effective once received in their office and a policy number will be available once the application has been processed.
