As the 2021-2022 school year began, HBCSD engaged with stakeholders for additional input regarding needs and to seek input regarding safe in-person learning, lost instructional time, and other pandemic impacts. After the first three weeks of school, another ThoughtExchange was launched to identify new and ongoing needs, assess priorities, and provide input regarding ESSER III funds. Additionally, as committees and groups met, HBCSD leadership sought input. For example, HBCSD leaders met with association groups, Title I parent group, PTA/PTSA, DAC/DELAC, DATE/TUPE/Health Council, and SELPA members to seek input.

HBCSD engaged in meaningful consultation with parents, employees, and students from September 29 through October 12 by survey (ThoughtExchange). Meaningful consultation with the following stakeholders included:

- PTA/PTSA leaders on October 5 by meeting.
- Parents of at risk students, English learners, homeless, foster youth from October 4-15, 2021 by phone calls
- DAC/DELAC representatives on October 20, 2021 via in-person meeting
- Classified bargaining unit leaders on October 4 via in-person meeting
- Certificated bargaining unit leaders on October 5 via in-person meeting
- Site and district administrators, including special education administrators, on October 13, 2021 via virtual meeting
- Other educators and staff provided meaningful consultation on September 29, 2021 (DATE/TUPE/Health Council) and September 30, 2021 (LMTs) via in-person meeting and virtual meeting, respectively.
- Preschool Advisory Committee- Oct. 14 via ZOOM

HBCSD evaluated its stakeholder engagement opportunities and determined that civil rights groups, tribes, and migrant students are neither present nor served by the LEA.

The plan was influenced by analyzing and identifying common themes and needs that emerged from the input provided by the various stakeholder engagement processes. Feedback from the community engagement strategies described above was incorporated into the development of the specific strategies for addressing the loss of instructional time and providing supplemental instruction and support to identified students. Additional feedback from the ELOGP and LCAP remained consistent with current feedback, including a commitment to in-person learning, smaller class sizes, counseling supporting programs, small group support for math and reading, student interventions, enrichment opportunities and high quality summer school opportunities. The services and opportunities for students as described in the ESSER III plan incorporates the most recent feedback and continues to build on

the ELO and LCAP goals of supporting safe and continuous in-person learning and addressing the academic, social/ emotional, and mental health needs of all students.

ESSER III Expenditure Plan Instructions

Introduction

 Act, upon request; and
- Be made publicly available on the LEA's website.

 in a distance learning environment, and
 - Tracking student attendance and improving student engagement in distance education;
