Call to Order: Rachel DeGroat opened the meeting at 7:02 with the Pledge of Allegiance.

Approval of Minutes: Chris Jay made a **MOTION** to approve the minutes of the July 16, 2018 Board of Education Meeting, seconded by Tara Sears and carried.

Chris Jay made a **MOTION** to approve the minutes of the August 8, 2018 Board of Education Meeting, seconded by Tara Sears and carried.

Chris Jay made a **MOTION** to amend the date from August 8, 2018 to read August 2, 2018, seconded by Sarah Williams and carried.

CSE/CPSE/504 Tom Ordway made a **Motion** to accept the CSE/CPSE/504 Reports seconded by Tara Sears and carried.

Motions:

Tom Ordway made a **MOTION** to appoint Ronda Morris as the Standing Together Advisor at \$400.00 for the 2018-2019 school year, seconded by Chris Jay and carried.

Tara Sears made a **MOTION** to accept the Community Eligibility Provision for the 2018-2019 school year. Mike Markwica spoke regarding CEP, explaining the benefits and Costs. The **MOTION** was seconded by Tom Ordway and carried.

Chris Jay made a **MOTION** to except the following resolution: BE IT RESOLVED that the Board of Education of the Johnsborg Central School District hereby designates Superintendent, Michael J. Markwica as the representative of the District to make all determinations regarding the eligibility of students to enroll, on a tuition free basis, in the schools of the district. This designation affords Superintendent, Michael J. Markwica all rights and responsibilities pursuant to Part 100.2(y) of the regulations of the Commissioner of Education. Mike Markwica Explained that this resolution was at the suggestion of the school's lawyers. The **MOTION** was seconded by Sarah Williams and carried.

Tom Ordway made a **MOTION** to appoint Lawrence Ringer as a Purchasing Agent when the Superintendent is unavailable, seconded by Chris Jay and carried.

Tom Ordway made a **MOTION** to appoint Janice Conner as the Extra Curricular Fund Central Treasurer for the 2018-2019 School year, seconded by Sarah Williams and carried.

Tom Ordway made a **MOTION** to approve Ronda Morris as School Counselor at Step 1 of JCSTA contract (2 periods a day) Effective 9/1/2018. Mike Markwica reported that advice from the school's attorney we have to pay Mrs. Morris two hours per day under the JCSTA contract but she will receive her benefit package from the CSEA union. The **MOTION** was seconded by Sarah Williams and carried.

Tom Ordway made a **MOTION** to accept the Tax Warrant. Larry Ringer provided a handout of the 2018-2019 Tax Warrant. The **MOTION** was seconded by Chris Jay and carried.

William Conner made a **MOTION** to accept the Employee Retirement Reserve. Larry Ringer explained this new Program and how it will help us in the future. William Conner

asked if the Business Office could share this information with The Finance Committee prior to introducing it to the board. Mr. Ringer said he would. This **MOTION** was seconded by Tara Sears and carried.
