Approval of Minutes	T Ordway made a MOTION to approve the minutes of the April 13, 2015, Regular Board of Education Meeting.
CSE	T Ordway made a MOTION to accept the CSE minutes for 3/24/15, seconded by W Conner and carried.
Agenda Changes	ADD: Jill Toney and Andy Snide to discuss PE programs which could include the archery program. Executive Session regarding a legal issue.
PE Programs	Jill Toney and Andy Snide asked to come and talk about the archery program that was presented at a previous Board meeting. Both Jill and Andy said they were interested in other programs which they would like to discuss with the Board. Jill mentioned they had an archery program at one point just for gym class. Instead of archery they would like to see the fitness facility updated. They would like to move equipment to the cafetorium stage. Steve Tomb would also like to see this change as the Nordic Coach and said he would work with the PE department to look at the Carol White Grant. They were also interested in a SmartBoard to be put on cafetorium stage. They would like to see permanent tracking on the yellow brick road. A climbing wall or high ropes was also discussed. Jill reported that there are grants out there. Maybe as True North we could go for a bigger grant and split it.
