**Committee Reports:**

**School Safety:**

Heather Flanagan presented three surveys: Parent/Community, Student, and Staff. These surveys will be available online as well as paper copies.

Rachel DeGroat suggested that the June 14th meeting be Mentioned on the cover sheet.

William Conner expressed his feeling that the questions were too open ended and survey takers should be asked outright if they want an armed guard at school or not.

Erwin Morris suggested that if the questions were asked a certain way they would/could have a biased response.

**Update Report:**

**GroSolar:** Mike Markwica reported that the State of New York has given the okay to not be involved in the solar project. An employee from the company that will install the solar panels will be here tomorrow (5/22/18).

**Other Business:**

William Conner asked if we were going to have any security at Graduation. Mike Markwica responded by stating that we have Custodians stay at the school a full 24 hours before graduation. Mr. Conner was speaking more about security for safety benefits. Mr. Markwica said they will consider this.

Mike Markwica reported that the boys' varsity baseball team lost in the first round of sectional play and are finished for the season. The girls' varsity team received a bye in the first round and if weather permitting will play on May 22, 2018
