Tom Ordway made a **MOTION** to approve the New York State Power Authority Resolution as follows:

WHEREAS, pursuant to Commissioner's Regulation 155.9 school districts or Boards of Cooperative Educational Services (BOCES) are required to assume the role of lead agency for the Environmental review of all construction and renovation projects; and

WHEREAS, Department of Environmental Conservation Regulations 6 NYCRR 617 outlines the State Environmental Quality Review Act (SEQRA) process that is applicable to all School Districts, BOCES and other municipal subdivisions; and

WHEREAS, pursuant to the applicable statute and regulations, there is classification of projects known as Type II Actions that Are considered to have no significant environmental impact And that require no further review under SEQRA process; and

WHEREAS, the Board of Education School District has Proposed the following:
Energy Efficiency Project at Johnsburg School District

WHEREAS, the Board of Education of Johnsburg School District Has received an opinion from New York State Power Authority, it's agent in this project, advising that the above referenced Projects are Type II Actions.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Education of Johnsburg School District after reviewing the Above described projects and after considering 6 NYCRR 617.5 ©(8) of the implementing regulations of the SEQRA and, therefore, by definition, will have no significant environmental Impact and will require no further review under the SEQRA process.
