- 1) Class I, II, and III groups will not be charged any fees unless an employee, who is not regularly scheduled, must be present to ensure safety and/or the safe operation of certain equipment (see note 3). The fee for a custodial staff member not regularly scheduled to be present is \$50/hour.
- 2) All Class IV, and V facility use applicants are required to make a minimum security deposit of twenty percent (20%) of the rental fee upon approval of the organization's application. Failure to remit payment of the security deposit within ten (10) days of approval of the application may result in revocation of the facilities use permit. The District may, in its discretion, require a larger security deposit or require prepayment of all or a portion of the applicable rental, staffing and equipment fees depending on the nature and size of the requested event, and/or the applicant's payment history.
- 3) Depending upon the size and nature of your event, the District may, at its discretion, assign one or more representatives to serve in needed positions for your event. Organizations will be notified by the District, upon application, if additional personnel are required and the applicable rates the organization will pay.
- 4) If a facility is not listed, it is the District's right to set the applicable rate for that facility.
