

The school board has established attendance zones to facilitate the district's educational programs by regulating attendance, as efficiently as possible, at the various school buildings. Such zones are subject to periodic revision as deemed necessary by this board.

A student will attend school in a building serving his or her attendance zone. The student's attendance zone is based on his or her residence at the time of enrollment. The student's residence is the address of the parent or guardian enrolling the student. Proof of residency may be required. If the parent or guardian moves to a different attendance zone, the student will be transferred to the appropriate building. However, the superintendent is authorized to permit a student to complete a grading period in the initial attendance zone when such action is deemed to be in the best interest of the student.

All requests for an intra-district transfer must comply with the district's Open Enrollment policy. Deviation from this policy may occur for the education of exceptional children, and other extenuating circumstances as approved by the superintendent.

The attendance zones for this district are as follows:

### **Hubbard / Teed Elementary Attendance Zone**

Starting at the intersection of N Linder Rd and E Deer Flat Rd, the boundary follows N Linder Rd S including the E side of N Linder Rd only to the intersection of N Linder Rd / S Swan Falls Rd and E Avalon St turning W to connect to the intersection of W Avalon St and S School St including both sides of W Avalon St. The boundary then follows S School St including the E side of S School St only to W King Rd. Turning E on W King Rd the boundary includes both the N and S sides of W King Rd to the intersection of W King Rd and S Swan Falls Rd. Turning S on S Swan Falls Rd the boundary follows the E edge of the Indian Creek/Ross attendance boundary to the S District boundary, continuing to follow the District boundary S and E then N to E Hubbard Rd. Following the edge of the Silver Trail Elementary attendance boundary, the boundary turns W then S then W on E deer Flat Rd, including the S side of E Deer Flat Rd only, back to the intersection of N Linder Rd and E Deer Flat Rd.

### **Indian Creek / Ross Elementary Attendance Zone**

Starting at the District boundary on S Swan Falls Rd, the Indian Creek/Ross attendance zone follows the District boundary W to Highway 45, continuing to follow the District boundary N to the intersection of W Kuna Rd and S Powerline Rd. The boundary then follows W Kuna Rd E taking in both the N and S sides of W Kuna Rd to the intersection of N Black Cat Rd and W Kuna Rd. The boundary then turns N on N Black Cat Rd including the E side of N Black Cat Rd only, then follows the S Crimson Point Elementary attendance zone boundary E to the intersection of N School St and W Gold St, taking in Sego Prairie, Discovery Creek, Hayfield, Prospector and Butler subdivisions. The boundary then follows the S Reed Elementary attendance zone boundary E to N Linder Rd, turning S on N Linder Rd to include the W side of N Linder Rd to the railroad tracks at N Bridge Ave. The boundary then continues to the intersection of W Avalon St and S School St turning S to include the W side of S School St to W King Rd, not to include either sided of W King Rd to S Swan Falls Rd then back to the S District boundary at S Swan Falls Rd.

**Reed Elementary Attendance Zone**

The Reed Elementary attendance zone takes in Summit View and Heritage Farms subdivisions located at the SW corner of the intersection of W Deer flat Rd and N Linder Rd, as well as N School St, N of Prospector subdivision. The boundary crosses W Deer Flat Rd to include N Andrew Lane as well as Deer Horn and Stonegate subdivisions. The boundary crosses N Linder Rd to include Birds of Prey, Hawks Nest, Sable Ridge and Chaparossa subdivisions. The boundary then proceeds S to E Deer Flat Rd including the N side of E Deer Flat Rd back to the intersection of N Linder Rd and E Deer Flat Rd.

**Crimson Point Elementary Attendance Zone**

The Crimson Point Elementary attendance zone takes in Gold Creek and South Palomar subdivisions located at the SW corner of the intersection of W Deer Flat Rd and N School St as well as N Ten Mile Rd N of the Kuna Middle School. The boundary crosses W Deer Flat Rd to include Mineral Springs and N Palomar subdivisions. The boundary then proceeds N on Ten Mile Rd including both E and W side of Ten Mile Rd to the intersection of W Hubbard Rd and N Ten Mile Rd. The boundary then proceeds W to the railroad tracks following the E side of the railroad tracks to the W District boundary, continuing to follow the District boundary S and W to the intersection of S Powerline Rd and W Kuna Rd including the area N of W Kuna Rd. Proceeding E to the intersection of W Kuna Rd and N Black Cat Rd the boundary follows N Black Cat Rd to N Big Tree Lane, the NE back to S Palomar subdivision on N Ten Mile Rd.

**Silver Trail Elementary Attendance Zone**

Starting at the District boundary at the intersection of S Five Mile Rd and E Hubbard Rd the Silver Trail attendance zone follows E Hubbard Rd W to include both the N and S sides of E Hubbard Rd to the intersection of N Stewart Rd and E Hubbard Rd, including both sides of N Stewart Rd to the intersection of N Stewart Rd and E Hubbard Rd, including both sides of N Stewart Rd to the intersection of E Deer Flat Rd and N Stewart Rd. The boundary then proceeds W on E Deer flat Rd to include the N side of E Deer Flat on to N Kay Ave. The boundary then follows the E side of the Reed Elementary attendance zone boundary N to W Hubbard Rd turning W on W Hubbard Rd to N Linder Rd including the N side of W Hubbard Rd only. The boundary continues to follow N Linder Rd S to E Ardell Rd including Arbor Ridge subdivision, connecting to the intersection o W Ardell Rd and N Ten Mile Rd including Walnut Creek subdivision, turning W on W Hubbard Rd to the E side of the railroad tracks including both sides of Hubbard Rd. The boundary then follows the railroad tracks to the W District boundary, following the District boundary N then S then E then S to the intersection of S Cloverdale Rd and E Columbia Rd, including Three Oakes subdivision. Continue to follow the District boundary E on E Columbia Rd to S Five Mile Rd including the S side of E Columbia Rd only and Carmichael subdivision. Turning S on S Five Mile Rd follow the District boundary to include the S side of S Five Mile Rd only and Fox Ridge subdivision, continue to follow the District boundary back to the intersection of S Five Mile Rd and E Hubbard Rd.
