A. WEEKLY

Lawn Areas

1. Mowing, trimming and hard edging, and blowing all areas.
2. Trash pickup.
3. Spring and fall clean up

B. MONTHLY:

1. Provide detailed timely monthly invoices to include the number of mowing services for invoice period, all additional services are to be outlined separate and itemized on same invoice.

C. ANNUALLY

1. Spring and fall clean up. Includes 1x per year to remove excessive leaves (including beds).

D. Bid #1 - Game Fields (football, soccer, baseball, and softball) and surrounding area.
