



## Velasquez Elementary Parent Involvement Policy 2023-2024

1. **Velasquez** will take the following actions to involve parents in the joint development of its school parental involvement plan under section 1116 (c) (1) (2) of the ESSA:
  
2. **Velasquez** will take the following actions to involve parents in the process of school review and improvement under section 1116 (c) (1) (2) of the ESSA:
  - *Site based meetings (parent, teacher and administration)*

3. **Velasquez** will hold an annual meeting to inform parents of the school's participation in Title I, Part A programs, and to explain the Title I, Part A requirements and the right of parents to be involved in Title I, Part A programs. The school will convene the meeting at a time convenient for parents and will offer a flexible number of additional parental involvement meetings, such as in the morning or evening, so that as many parents as possible are able to attend. 4. **Velasquez** will provide parents of participating children information in a timely manner about Title I, Part A programs that includes a description and explanation of the school's curriculum, the forms of academic assessment used to measure children's progress, and the proficiency levels students are expected to meet by:
  - *sharing the information during the annual Title I meeting and Parent Orientation Meeting*
  - *sharing the information in Canvas Parent Portal*
  
5. **Velasquez** will at the request of parents, provide opportunities for regular meetings for parents to formulate suggestions and to participate, as appropriate, in decisions about the education of their children. The school will respond to any such suggestions as soon as practicably possible by:
  - *meeting with parents, sending home emails, mail or bilingual call outs*

6. **Velasquez** will provide each parent an individual student report about the performance of their child on the State assessment in at least math, english language arts reading by:
  - *student's reports will be released through Skyward Family Access. Parents may request a paper copy as well.*
  
7. **Velasquez** will provide assistance to parents of children served by the school, as appropriate, in understanding topics by undertaking the actions described in this paragraph --
  - the state's academic content standards,
  - the state's student academic achievement standards,
  - the state and local academic assessments including alternate assessments,
  - the requirements of Part A,
  - how to monitor their child's progress, and
  - how to work with educators:
  - *parent conferences, informing parents about student's progress*
  
8. **Velasquez** will provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training and using technology, as appropriate, to foster parental involvement, by:
  - *Offering parent involvement sessions to provide support for parents in assisting their students with technology, literacy, and math*
  
9. **Velasquez** will, with the assistance of its parents, educate its teachers, pupil services personnel, principals, and other staff in how to reach out to, communicate with, and work with parents as equal partners in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools, by:
  - *Providing training and staff development meetings regarding parent involvement and meaningful partnership.*
