I, _____, understand that the privilege to drive to school is granted to me based on my responsibility.

- * Students are permitted to drive to school and park on school premises as a matter of **privilege**, not as a matter of right.
- * I agree to follow acceptable standards while driving that are safe and prudent.
- * I understand that inappropriate behavior while on school premises could result in the loss of driving privileges.
- * Any Student who has **3 or more F's the previous grading period, is on social probation, or owes any fines or fees, will not be permitted to drive or park on school premises.** Eligibility based on these criteria will be evaluated at the end of each quarter.
- * If a student's drivers' license is suspended/revoked, it is the student's responsibility to turn in their parking tag to the office.
- * Students who drive more than one vehicle must register each vehicle and display a parking permit in the vehicle they are driving.
- * **Parking permits are not transferable** and may be used solely by the student registered. Loaning of permits may result in disciplinary consequences for both parties.

Parking Regulations

- Attach PARKING PERMIT to the rear view mirror support so it is clearly visible from outside the vehicle.
- Students must park in student parking lot only. The front parking lot and PAC parking lot are reserved for faculty/staff.
- The security of your permit & your vehicle is your responsibility. Lock your parked vehicle.
- All Student Parking is first come, first serve. Saving parking spots is not permitted.
- The speed limit is **10 MPH**.
- No loitering or littering in the parking lot.
 - Upon arrival, students should park, secure their vehicle, and enter the high school.
 - Upon dismissal, students should leave the lot directly; re-parking is not permitted.
 - Visiting the parking lot during school hours without permission from a principal may result in disciplinary consequences.

I UNDERSTAND AND ACKNOWLEDGE THAT:

1. **STUDENTS ARE PERMITTED TO PARK ON SCHOOL PREMISES AS A MATTER OF PRIVILEGE, NOT RIGHT.**
2. **THE SCHOOL DISTRICT RETAINS AUTHORITY TO CONDUCT ROUTINE PATROLS OF STUDENT PARKING LOTS AND INSPECTIONS OF THE EXTERIORS OF STUDENT AUTOMOBILES ON SCHOOL PROPERTY.**
3. **THE SCHOOL DISTRICT MAY INSPECT THE INTERIORS OF STUDENT AUTOMOBILES WHENEVER A SCHOOL AUTHORITY HAS REASONABLE SUSPICION TO BELIEVE ILLEGAL OR UNAUTHORIZED MATERIALS ARE CONTAINED INSIDE THE AUTOMOBILE.**
4. **SUCH PATROLS AND INSPECTIONS MAY BE CONDUCTED WITHOUT NOTICE, WITHOUT STUDENT CONSENT, AND WITHOUT A SEARCH WARRANT.**
5. **IF I FAIL TO PROVIDE ACCESS TO THE INTERIOR OF MY CAR UPON REQUEST BY A SCHOOL OFFICIAL, I WILL BE SUBJECT TO DISCIPLINARY ACTION.**
