III. New Business

- 1. Guests Gary Thomas
 - a. Presentation about the Bond
 - Asked school board for names from the precinct and formed committee - going over every school in the district and their needs as fas a buildings
 - ii. Cache is the 10th largest district in the state
 - iii. Reviewed buildings affected by previous bond (10 years ago)
 - iv. We've grown by 4200 students since the last bond
 - v. This means lots of buildings over capacity! 38 portables are being used in the district
 - vi. All Day Kindergarten (ADK) should be provided for all communities, but need more classrooms to do it.
 - vii. How can we meet the needs without raising taxes?
 - 1. Proposed bond for 2023 \$139 million dollar bond
 - a. 2 new middles schools
 - b. 2 new elementary schools (Spring Creek converted)
 - c. Safety enhancements in all schools
 - d. Moves 6th grade back to the middle schools

- e. Provides ADK to all 27 communities
- f. Provides a feeder school for each high school
- 2. School safety upgrades
 - a. Upgrade PA systems
 - b. Access control
 - c. Controlled entry
 - d. Surveillance
 - e. Enhanced communication
 - f. Standards response protocol
- 3. This \$139 million bond resolution will be on the ballot in November. If approved, the bond will be paid off in 20 years.
- 4. Taxes will NOT increase because this bond will be layered into the existing bond. Average home will pay \$234 next year, whether the bond passes or not.
- 5. It will be done by a local contractor (boosts our economy and local help means they can troubleshoot any problems asap)
 - a. If it passes, the middle schools will be done in the fall of 2026 and the elementary fall of 2027.
- 6. Will there be a magnet school?
 - a. The decision will be brought to parents and the school board.
 - b. Spring Creek and Cedar Ridge could be magnet schools for DLI.
 - i. Lots of pros
 - 1. Class sizes would be more equitable
 - 2. Not as divided in the community
 - 3. Could help parents get 1st or 2nd choice
 - ii. Cons
 - Parents will have to drive further to take their kids
 - 2. Transportation issues the state does not reimburse for bussing because it's an optional program
