(District: 60.9 percent; State: 46.5 percent). - ----Online reading/research curriculum is needed to support and differentiate LA instruction (\$2400).
- -----We rely heavily on student-use technology (i.e., computers, Chromebooks, Chromeboxes, iPads, etc.) to support our teaching/learning efforts in Language Arts and all other content areas, This money will help us replace our ageing-out machines and devices (\$2000).
