A. Data Review - ACADIENCE.

Our goal for Acadience testing was to improve 2 points for kids who were testing below benchmark. We have been measuring from mid-term testing to mid-term. We did not meet the goal for this year. There are a few reasons that we think this happened. The lockdown and transition to online learning last year for three months was a factor. Providence has also received a large number of new students enrolling from other schools this year. Many of these kids are students with IEP's. Individually we did see good growth.

Midterm test is the most difficult. There was discussion at looking at end of year testing for this next year as those scores would reflect a full year of in-person instruction. We have an excellent Tier II Reading program that really targets skills kids are lacking. Reading groups have been more broad this year due to trying to keep kids only with their classmates for contact tracing. With less restrictions the reading facilitator is looking to group kids at the same reading level by grade again instead of just in single classes. This can help target specific skills.
