- 3. Briefly report how the school is implementing the 2011-2012 School Plan and how the School LAND Trust money is being spent. BE SPECIFIC!
- * MATH The teachers, administration, and support staff at North Cache 8-9 Center continue to focus on the most critical academic needs in the areas of math, science, reading, and writing. Our math teachers have recently begun using the new common core as their guide for curriculum instruction. They have also continued in their efforts to identify students who struggle academically and have designed and implemented team-taught classes in Pre-algebra that provide additional support.
- * LANGUAGE ARTS In the area of language arts, we continue to take multiple measures to provide additional support to those students who are reading and writing below grade level. We continue to collaborate with our feeder schools in proctoring the Diagnostic Assessment of Reading in an attempt to identify those students who would directly benefit by being participants in the "Language!" program. The DAR assessment also serves as a baseline for measurement of growth throughout the year. The students in the "Language!" program participate in consistent benchmarking assessments. Our language arts teachers also use the Utahwrite software program to assess student ability in essay writing. Three benchmark assessments are administered throughout the school year. These assessments follow consistent instruction throughout the year regarding the six+one traits of writing.
- * **SCIENCE** Our 8th grade science teachers have created formative assessments for each objective as part of all the standards included in the 8th grade core curriculum. All 8th grade students have participated in each assessment both before and after instruction. These scores were calculated and reviewed by each teacher to determine student growth in each standard and objective. Our science teachers continue to use these assessment results in a PLC environment to explore areas of strength and weakness in content delivery and to implement strategies to increase student comprehension.

North Cache continues to use the majority of the funds provided by the Utah Land Trust to facilitate the AMProgram (Academic Mentor Program). This program is designed specifically to provide additional adult support to those students who struggle academically in the areas listed above. Our adult mentors monitor student homework completion, assist in aiding students with work during the homeroom period, and work with teachers in the classroom.

Goal 1

State the SPECIFIC goal

We have updated our goal as we found there are a few problems with our measurements. Our goal was to improve the pre to post test scores by 20%. We are modifying it as follows. We will improve the pre to post test scores by 20% for students scoring up to 80% on the pre test. We will show at least a 5% improvement for those at 81% and above. We will also develop common summative standard assessments throughout our eighth grade class rooms.

Academic areas for this goal.

Science

Common formative assessments will be given within each unit to check for student understanding. This will allow us to adjust teaching and provide additional learning opportunities for struggling students.

Outline the steps of the action plan to reach the goal

We will review and assess our common summative assessment to show that the results are an accurate measurement of learning. We will use the common summative assessment as a graded test to emphasize the importance of the assessment tool. Students who do not show improvement will be contacted and offered opportunities to receive extra instruction. North Cache 8-9 Center organized an academic aide homeroom program in an effort to identify and focus on 7-8% of the school population that is struggling. This mark is evidenced by their grades and year-end CRT scores in the areas of language arts, math and science. We will continue to work with those struggling students this year and further develop the efficiency and effectiveness of the program.

Goal 2

State the SPECIFIC goal

The North Cache Math Department has changed from the old core to the new, rigorous common math core. Our goal is to have at least 95% of our students pass their math courses for the school year. There will be an increased need for collaboration among math instructors. If monies are available, a staff development day for the math teachers of the school would be beneficial.

Academic areas for this goal.

Mathematics

Identify the measurement(s) you will use to determine if you are making progress towards the goal

Our math goal is directly tied to student grades. Both math teacher and individual homeroom teachers will monitor all student grades, but more specifically those students' grades who have been identified as struggling academically.

Those grades will be compared to previous year grades to determine the effectiveness of the math programs in place.

Outline the steps of the action plan to reach the goal

We will continue the process of identifying students who struggle in the area of mathematics. We have created a team-taught class that extends the math curriculum to two years for more continuity. Our teachers will continue to provide formative Common Diagnostic Assessment System (CDAS). Trustland monies have been budgeted and will be used to provide further training as it relates to the new common core that has been adopted this past year.

Goal 3

State the SPECIFIC goal

In the area of language arts, the 8th and 9th grade writing scores will be an average of 22.0 by the end of the 2012-2013 school year as measured by the Utah Writes Program. We will continue both our team-teaching approach and our employment of a special program called "Language!" At the end of each unit of study, 95% of our 8th and 9th grade team-taught students will score 70% or higher on Language! content mastery tests.

Academic areas for this goal.

Reading

Writing

Identify the measurement(s) you will use to determine if you are making progress towards the goal

Our language arts "Language!" program is 100% dependent on data collection and analysis. We will perform the DAR (Diagnostic Assessment of Reading) on students with low CRT (year-end) language arts scores to determine eligibility for the program. Once enrolled in the program, these students will be monitored for reading fluency and comprehension using Aimsweb, an assessment software program, and content mastery assessments within the Language! curriculum.

Finally, we will perform an exit DAR to measure overall growth in reading comprehension and fluency.

Each language arts instructor will administer a minimum of three essay exams throughout the 2012-2013 school year. The essay responses will be written using the Utahwrite software and be graded using the six traits rubric scale of 30 points. Our language arts teachers will use these exams to evaluate specific strengths and weaknesses in student work, and to tailor instruction based on those findings.

Outline the steps of the action plan to reach the goal

Salaries and Employee Benefits (100 and 200)

We continue to provide special services related to reading and writing through three team-teaching classes with students who scored a one or two on their CRT tests, or read significantly below grade level. We will continue to use a curricular program called "Language!" This program allows us to assist in literary development of students with reading levels at least two grade levels below their peers. To improve our students' writing skills we will continue to use the following programs: Utahwrite, Fluent Reader, Language!, and Step Up to Writing.
