TIMELY INFORMATION FROM THE BOARD AND **SUPERINTENDENT**

Dr. Howell thanked Jordan Elementary School teachers Allison Fonti, Barbara Castillo, Debbie Opfer, and Teddy Sachs for decorating the Bulletin Boards.

Dr. Howell also shared that the Lowell Joint Education Foundation is hosting its 1st Annual Fine Arts Extravaganza at the La Habra Community Center on Monday, April 21, 2014.

SCHOOL REPORTS

Mrs. Shackelford shared that Meadow Green qualified to apply for the California Distinguished School for the 2014 School Year. The application was submitted and approved. A validation visit took place on March 12, 2014. Meadow Green highlighted two signature practices, Explicit Direct Instruction and ST Math. Members of the School Board, School Site Council, Meadow Green staff, parents, and community were all a part of this validation process. The validation team will send a report to the State Superintendent stating that they did see evidence of Meadow Greens signature actions. Final word of the award should come by the end of this month. Smarter Balanced Testing will take place at Meadow Green on April 8 and 9 and April 22 through the 24. Students will take both English/Language Arts and Math as well as a performance task. Each test session is scheduled for one hour with testing. Meadow Green PTA is sponsoring a student Junior Olympics event to be held on Saturday, April 12, at 11:00 a.m. This will be preceded by a Pancake Breakfast. PTA is also sponsoring a Father Daughter Dance the evening of April 17, 2014. And, Kindergarteners will be going to the LA Zoo on April 24, 2014.

SCHOOL REPORTS Continued

Mr. Barber stated Jordan Elementary School is holding their monthly Citizenship Assembly on Friday, April 11, at 11:00 a.m., for those students who best portrayed the Character Education trait for the month of March. Jordan's PTA has a lot of planned events. These events are made possible by the donations and fundraisers that the PTA holds throughout the year. A *Science on the Go* Assembly will be held on Tuesday, April 15, for all grades. On Wednesday, April 16, the sixth grade students will travel to the California Science Center. The students will have the opportunity to explore the Space Shuttle Endeavor and other exhibits throughout the day. On Friday, April 25, the PTA will host a Family Fun Night Hoe Down at 5:00 p.m. at Jordan. On Monday, April 28, at 2:00 p.m. in Jordan's Library, we will be having our Annual Volunteer Tea. On Tuesday, April 30, Jordan will be having our monthly "Stove On Strikes" at McDonalds.

Mr. Schambeck reported that El Portal Elementary School finished the month of March, with our Quarter 3 Awards Assembly and our Honorary Service Awards. Mary Brewer was presented the Continuing Service Award and Suzanna Brintle received the Honorary Service Award. We also had our Senior Friends Day, on March 21. It was a packed house with a patriotic theme. The Ned Show, which stands for Never Give Up, Encourage Others, and Do Your Best, will be here on Friday, April 4. It is a yoyo presentation that encourages students to work hard in school and make good choices. Our 3rd through 6th grade teachers are all gearing up for the new Smarter Balance Field Test beginning on April 15 through April 29. El Portal will help fill the food pantry of the La Habra Community Center the week of April 21 through 25. It will be the last service project of the year.

Mr. Hinz stated that Macy Elementary School's Kindergarten Round-Up will be held on Thursday, April 10. Prospective Kindergarteners will meet with the school nurse, school psychologist, and the principal. Parents and the prospective Kindergarteners will tour kindergarten classrooms and enrollment papers and records will be reviewed. On Friday, April 30, the special education classes will attend the California State University, Fullerton, Special Games. Hundreds of special needs students from all over the Southern California area will participate in these athletic events. All students will receive free drinks, coupons, and a Special Games T-shirt. Common Core testing begins tomorrow April 8th at Macy. Our students and teachers have been diligently preparing for the new online assessments.

Students and teachers will get a great look at what is ahead next year. This month Rancho is hosting incoming seventh grade students as they take Honors placement tests in English/Language Arts and Math. Teen Truth Live will be with us to do a drug and alcohol prevention assembly April 10. Our competitive drumline competes every Saturday in April and our choir is performing in an invitational on Saturday, April 5. The Jerry Luzzi Memorial Soccer Tournament will take place at Rancho-Starbuck the last week of April and Physical Fitness testing takes place the same week.
