TIMELY INFORMATION FROM THE BOARD AND Dr. Bell thanked Sarah Ornelas, IMC technician, for decorating the Bulletin Boards.

SUPERINTENDENT

Dr. Bell shared that during the Winter Recess Vicki Luna, Fiscal Services Clerk, retired after 25 years. Due to Vicki's retirement, Lisa Zampini was welcomed today as the newest employee of the District. Ms. Zampini hails from Tustin Unified School District working in the Business Services Department.

SCHOOL REPORTS

Mr. Hinz shared today Macy Elementary School students were treated to an assembly to kick off the MARS (Macy Awesome Reading Stars) Reading Program. Mr. Schambeck stated that El Portal Elementary sends a special thanks to Mrs. Shackelford, Mr. Barber, Mr. Schambeck, Mr. Hinz, and Dr. Bell for attending their annual holiday performance' "The Polar Express." The students worked hard and it was a great way to begin the holiday season. They appreciated all of guests for taking this time to be with us. El Portal first grade students will have had two lectures, from the Mt. Conservancy Ranger, before they hike Powder Canyon in La Habra Heights on January 9. On January 23, El Portal's third grade students will go to the Environmental Nature Center in Newport Beach. The month will end with the Discovery Center coming to El Portal lecturing on the water cycle for every grade-level. They have aligned all of their materials to the Common Core Standards for each grade level.

Dr. Bell shared "In accordance with the 2013-2016 Contractual Agreement between the Lowell Joint School District and the Lowell Joint Education Association/California Teachers Association/National Education Association, Article I: Agreement, the Lowell Joint School District is reopening and proposing to negotiate contractual issues. Furthermore, Article I stipulates that for the 2014/15 school year, the parties agree to limit reopener negotiations to only Article XXIV (Salaries), Article XXV (Benefits), and up to two other articles.

The Lowell Joint School District Management is proposing to negotiate the following additional section of the Collective Bargaining Agreement: Article XIV (Class Size Policy).

President Shackelford conducted a Public Hearing was opened at 7:52 p.m. and no public comments were received. The Public Hearing was closed at 7:53 p.m.

UPDATED/REVISED BOARD POLICIES (FIRST READING) As the District updates current Board Policies and accompanying Administrative Regulations regarding Health Examinations (BP 4112.4 and 4312.4) with current regulations and procedures, it is imperative to disseminate updated information. The proposed updated/revised Board Policies have been shared with representatives of the certificated and classified employee groups and administrators.

Further input is welcome and the revised Board Policies will be included on the February 2, 2015, Board agenda for second reading and approval.

PRESENTATION OF INDEPENDENT AUDIT REPORT 2013/14

Education Code Section 41020.3 requires that by January 31 of each year, the governing body of each local education agency shall review, at a public meeting, the annual audit of the local education agency for the prior year, any audit exceptions identified in that audit, the recommendations or findings of any management letter issued by the auditor, and any description of corrections or plans to correct any exceptions.

Dr. Bell reviewed the 2013/14 Independent Audit Report with the Board of Trustees, which was administered by Quezada, Wong, & Associates, Inc., Certified Public Accountants, and reported that there were no audit findings or recommendations, therefore no corrective actions were required. There are two phases of testing once during the spring and the other during the fall/winter. The District is in compliance with State and Federal laws, regulations, and guidelines.

2014 PHYSICAL FITNESS TEST

Per California *Education Code* Section 60800, each school district must administer a physical fitness test annually to all students in grades five, seven, and nine. Dr. McDonald shared the Spring 2014 Physical Fitness Test Results for grades 5 and 7. Currently, 64 percent of seventh grade students have already met the tenth grade fitness requirement, while 17 percent are only one standard away. The District will work with Principal's to analyze the data of the Physical Fitness Test results and develop plans for improvement in the areas where there were decreases.
