LCFF Overview

- Local Control Funding Formula (LCFF)
- New K-12 financing system
- First major school funding reform in 40 years
- Establishes 2020/21 funding target for all school districts
- Simplifies K-12 district funding once funding model is fully implemented
- Funding based on demographic profile of students
- Each district's funding is unique depending on student demographics and distance to individual funding target
- Increases flexibility at local level by reducing state expenditure restrictions
- Increases accountability and participation at the local level

LCFF Major Changes

Simplified Funding Model

- Replaces complex revenue limit finance system
- Most categorical programs removed and funding included in "base"
- Adds complexities during transition to full implementation

Increased Flexibility

- Eliminates burden of categorical funding requirements
- Decisions regarding student programs made at local level

Additional funding provided for:

- English Learners
- o Low Income Students
- Foster Youth

• Requires Local Control Accountability Plan (LCAP)

LCAP Overview

- Local Control Accountability Plan (LCAP)
- Identifies goals to improve or increase services to students
- Focuses on student achievement and outcomes
- Creates stronger link between budget process and educational programs
- Plan Driven What are we going to do?
- Budget reflects plan
- Outcome based How well did we do?
- Accountability Districts are responsible for outcomes
- Local Input What are our needs?

LCAP Overview

Three-year Plan

- Sets annual goals
- Approved by Board of Trustees
- Updated annually to reflect progress
- Defines how resources will be used
- Focuses on student outcomes







- Parents of Students with Special Needs






School Climate (Safety Issues):
