LJSD English Learner Program Update

Reviewed and discussed the reclassification processes, the ELD Progress Reports, reclassification monitoring, and the English Language Learning Assessment (ELLA). LJSD is currently in the process of reclassifying English learners that have met the reclassification criteria to Fluent English Proficient. Students who have been reclassified must be monitored for two year, if a student begins to struggle the school re-evaluates the student's progress and intervention measures are recommended. The ELD Progress Report is a tool used to provide ongoing record of student growth through the English proficiency levels. The ELLA mirrors the CELDT and provides data to measure growth with language proficiency.
