### **OPERATIONAL BLUEPRINT FOR SCHOOL REENTRY 2020-21**

## Updated 10/30/2020

Under ODE's *Ready Schools, Safe Learners* guidance, each school<sup>1</sup> has been directed to submit a plan to the district<sup>2</sup> in order to provide on-site and/or hybrid instruction. Districts must submit each school's plan to the local school board and make the plans available to the public. This form is to be used to document a district's, school's or program's plan to ensure students can return for the 2020-21 school year, in some form, in accordance with Executive Order 20-25(10). Schools must use the *Ready Schools, Safe Learners* guidance document as they complete their Operational Blueprint for Reentry. As a district, we collected survey data from Spring Distance Learning for All regarding successes and struggles, technology availability and needs for next school year, preferences of students and parents regarding learning model for the 20-21 school year, and intent to send students on site (if available) for instruction for the 20-21 school year. The survey link was provided to all students, families, and staff members to ensure effective representation and data from all levels of students, including demographics and our underserved and marginalized student/community groups. We provided paper copies of the survey upon request.

During on-site registration in early August, as a district, we surveyed our parents and students regarding the comprehensive distance learning model of instruction, access to nutrition services, technology needs, and internet availability.

Approximately 80% of our families fall into the underserved and marginalized student population. Our survey data collected both electronically and in person represents those families.

#### Describe why you are selecting Comprehensive Distance Learning as the school's Instructional Model for the effective dates of this plan.

Mapleton Elementary School will be providing Comprehensive Distance Learning until state and county metrics are met. At that time, we will transition to a hybrid model, allowing students to return to onsite learning in alternating groups. We recognize that distance learning has significant impacts on our families and are thankful for the continued sacrifice of our staff and community. By beginning the 2020-2021 school year in CDL, it will allow staff and families to plan for a return to onsite/hybrid learning and the new protocols that will be in place.

Health and safety of our staff and community are top priority and while we would much prefer in-person instruction, we will scale towards these models in purposeful ways. As decisions are made regarding shifting to K-3 and limited on-site instruction, we will utilize our equity decision making tools to prioritize students who are not finding success in the comprehensive distance learning model, as well as students who have limited access to internet, students navigating poverty, homelessness, and foster care, students of color, students learning English, and students with disabilities when determining which students will attend for limited on-site instruction.

Finally, we learned a lot from Distance Learning for All in the Spring, both what works and what does not work. This fall, our CDL model will be far better because of the lessons learned and the feedback from our community. We will continuously seek feedback from our students, families, and staff. Our goal is to maximize connection, care, and learning from a distance until we can learn together in person.

Mapleton School District has been operating in Comprehensive Distance Learning since the opening of school this year. At this time, due to COVID-19 rates in our county, we are in the Orange zone and unable to open for K-3. We are however, moving to provide limited in person instruction, in order to better support students with access and success in distance learning, as well as opportunities to support social emotional learning.

Mapleton School District has reviewed the comprehensive district learning (CDL) requirements detailed in the Oregon Department of Education document entitled: "Comprehensive Distance Learning: A Companion to Ready School, Safe Learners." Our comprehensive distance learning

model complies with all required guidelines.

We attest that we have reviewed and can meet the Comprehensive Distance Learning Guidance, and that all limited in person opportunities are both optional and supplemental to core instruction provided through CDL.

Mapleton School District will monitor state and county data continuously and make decisions that meet the health, safety, and learning needs of our students, families, and staff. The guidance prioritizes K-3 on-site instruction and limited on-site instruction (allowable in the exceptions). Mapleton meets the exception to provide limited in person on site instruction, we recognize that the data is unpredictable and ever-changing, adding an extra layer of complexity in our decisions to reopen before the statewide metrics are met. We will continue to explore possibilities for on-site instruction for our youngest students, as well as limited on-site instruction for our students who qualify under limited on-site instruction.

A district team will review the weekly metrics as shared by ODE each Monday. Should Lane County and the State begin trending in the right direction for two weeks, we will plan to return to campus the week following the third week with state metrics met.

Mapleton School District will continue to operate in comprehensive distance learning with limited in person opportunities until Lane County rates move into the yellow zone. When our local and county rates are in the Yellow, we will convene to carefully plan a phased approach to bringing back K-3 students for in person instruction.

The remainder of this operational blueprint is not applicable to schools operating a Comprehensive Distance Learning Model.

#### Hybrid/Onsite Plan

Mapleton School District has updated our Communicable Disease Management Plan to specifically address the prevention of spread of COVID-19. This plan has been submitted to Lane County Public Health (541.682.4041) and will be available on our school website when approved by LCPH. All staff are being trained on risk mitigation practices and procedures and we are phasing in the start of Limited in Person Instruction in order to practice and train staff and students in expectations.

We are working directly with Lane County Public Health and Kate Blair will be notified of any case we hear about through our community, as well, she informs us of confirmed and presumptive cases connected to our school communities.

We continue to work together with Lane County Public Health and our Reopening Advisor from Lane ESD to inform our blueprints, Disease Management Plan, and procedures as guidance and new research is provided by ODE and OHA.

Pre-populated contact tracing logs are provided for every cohort and sign in sheets (no-pen provided) are located at every shared space (office, teacher workrooms, restrooms), along with signage to remind about face coverings, handwashing, and distancing. Itinerant and district staff who move between buildings are keeping daily interaction logs. Contact tracing logs are kept securely for four weeks by Admin Assistant Carly Duval and will be provided to Lane County Public Health upon request.

Superintendent Jodi O'Mara updates the weekly report to ODE to report instructional model and the number of students/cohorts on campus.

In the case of student or staff illness, ODE's COVID Scenarios guide and consultation with Lane County Public Health will be used to inform communication and isolation, quarantine, and shift instructional models for individuals, cohorts, or the entire school.

#### OHA/ODE Requirements

Serve students in high-risk population(s) whether learning is happening through On-Site, Hybrid (partially On-Site and partially Comprehensive Distance Learning models), or Comprehensive Distance Learning models.

# Medically Fragile, Complex and Nursing-Dependent Student Requirements

- All districts must account for students who have health conditions that require additional nursing services. Oregon law (ORS 336.201) defines three levels of severity related to required nursing services:
  - Medically Complex: Are students who may have an unstable health condition and who may require daily professional nursing services.
  - Medically Fragile: Are students who may have a lifethreatening health condition and who may require immediate professional nursing services.
  - 3. Nursing-Dependent: Are students who have an unstable or life-threatening health condition and who require daily, direct, and continuous professional nursing services.
- Staff and school administrators, in partnership with school nurses, or other school health providers, should work with interdisciplinary teams to address individual student needs. The school registered nurse (RN) is responsible for nursing care provided to individual students as outlined in ODE guidance and state law:
  - Communicate with parents and health care providers to determine return to school status and current needs of the student.
  - Coordinate and update other health services the student may be receiving in addition to nursing services. This may include speech language pathology, occupational therapy, physical therapy, as well as behavioral and mental health services.
  - Modify Health Management Plans, Care Plans, IEPs, or 504 or other student-level medical plans, as indicated, to address current health care considerations.
  - The RN practicing in the school setting should be supported to remain up to date on current guidelines and access professional support such as evidence-based resources from the Oregon School Nurses Association.
  - Service provision should consider health and safety as well as legal standards.

#### Hybrid/Onsite Plan

#### Staff

\*Plan includes all staff self-identifying as vulnerable or part of a vulnerable household.

- Redeployed options could include:
  - On-line instruction and support
  - Maintenance projects, custodial work, office work without student/staff contact
- Staff could consider all leave options as well

#### **Students**

- All students identified as vulnerable, either by a physician, or parent/guardian notification, will be enrolled in online instruction with daily checks for participation and/or contact.
- Students who experience disability will continue to receive specially designed instruction.
- Students with language services will continue to receive English Language Development.

#### Visitors/Volunteers

Visitors/Volunteers will be unable to work in schools, or complete other volunteer activities that require in person interaction, at this time. Adults in schools are limited to essential personnel only.

Medical grade PPE is available for interaction with students demonstrating symptoms.

- Support physical distancing in all daily activities and instruction, maintaining six feet between individuals to the maximum extent possible.
- Minimize time standing in lines and take steps to ensure that six feet of distance between students is maintained, including marking spacing on floor, one-way traffic flow in constrained spaces, etc.
- Schedule modifications to limit the number of students in the building (e.g., rotating groups by days or location, staggered schedules to avoid hallway crowding and gathering).

Limited in person cohort schedules have been carefully planned in order to meet distancing and cohort limitations.

Physical distancing will be taught and reinforced through signage and instructions/reminders/positive reinforcement. There are no passing times; however, entry and exit is structured to maintain distancing between students and to keep cohorts separate.

Many staff meetings are held virtually, any in person trainings are held in gymnasiums, or outside as weather permits, and staff are physically distanced with well over 6 feet between participants.

#### 1d. COHORTING

#### OHA/ODE Requirements

- Where feasible, establish stable cohorts: groups shall be no larger than can be accommodated by the space available to provide 35 square feet per person, including staff.
  - The smaller the cohort, the less risk of spreading disease. As cohort groups increase in size, the risk of spreading disease increases.
- Students cannot be part of any single cohort, or part of multiple cohorts that exceed a total of 100 people within the educational week. Schools must plan to limit cohort sizes to allow for efficient

#### **Hybrid/Onsite Plan**

Each cohorts has been assigned their own bathroom, and sanitation/cleaning will be completed daily and between cohorts. Each bathroom is now gender neutral, and students will only use one at a time.

Each student is assigned their own desk, which will not be shared across cohorts. Cleaning of shared surfaces (door handles, table surfaces) will occur between student uses using provided disinfecting wipes.

contact-tracing and minimal risk for exposure. Cohorts may change week-to-week, but must be stable within the educational week.

- ⊠ Each school must have a system for daily logs to ensure contract tracing among the cohort (see section 1a of the *Ready Schools*, *Safe Learners* guidance).
- Minimize interaction between students in different stable cohorts (e.g., access to restrooms, activities, common areas). Provide access to All Gender/Gender Neutral restrooms.
- Cleaning and disinfecting surfaces (e.g., desks, door handles, etc.) must be maintained between multiple student uses, even in the same cohort.
- Design cohorts such that all students (including those protected under ADA and IDEA) maintain access to general education, gradelevel academic content standards, and peers.
- ✓ Staff who interact with multiple stable cohorts must wash/sanitize their hands between interactions with different stable cohorts.

#### Hybrid/Onsite Plan

Cohorts are limited to 20 students (under 15 in most cases) for no longer than 2 hours each day.

Tracking attendance carefully within cohorts will be critical to support contact tracing. Contact tracing logs will be maintained for each cohort, each day. ODE's contact tracing log will be used in each classroom. Additionally, each staff member will keep their own log throughout each day. Daily logs will be compiled and kept for four weeks with our school secretary Carly Duval.

Teachers/Admin/EAs/specialists/bus drivers will be limited to three cohorts in a single day and five per week.

#### **Transportation Cohort**

Students cannot be part of more than two cohorts each week, including their bus cohort, which also will not exceed 20 total people on the bus.

#### 1e. PUBLIC HEALTH COMMUNICATION

#### **OHA/ODE Requirements**

- Communicate to staff at the start of On-Site instruction and at periodic intervals explaining infection control measures that are being implemented to prevent spread of disease.
- Develop protocols for communicating with students, families and staff who have come into close contact with a person who has COVID-19.
  - The definition of exposure is being within 6 feet of a person who has COVID-19 for at least 15 cumulative minutes in a day.
- Develop protocols for communicating immediately with staff, families, and the school community when a new case(s) of COVID-19 is diagnosed in students or staff members, including a description of how the school or district is responding.
- Provide all information in languages and formats accessible to the school community.

#### Hybrid/Onsite Plan

- Develop a Return-to-Work protocol
- Letter to staff, LIPI practices and protocols, include definition of close contact.
- Letter to families LIPI expectations and when to stay home guidance. Include definition of close contact.
- Share protocols on website

Mapleton SD will utilize LCPH screener training, as well as conduct training for all staff on health and safety protocols outlined in RSSL guidance and this blueprint specifically.

ODEs COVID-19 scenario guidance will be utilized in the case of someone who presents with symptoms or is a presumed or confirmed case. Communication with staff, families, and the community will utilize the templates available in this document. This blueprint will be available on our website and in the front office by request.

#### 1f. ENTRY AND SCREENING

## OHA/ODE Requirements

- Direct students and staff to stay home if they, or anyone in their homes or community living spaces, have COVID-19 symptoms, or if anyone in their home or community living spaces has COVID-19. COVID-19 symptoms are as follows:
  - Primary symptoms of concern: cough, fever (temperature of 100.4°F or higher) or chills, shortness of breath, difficulty breathing, or new loss of taste or smell.
  - Note that muscle pain, headache, sore throat, diarrhea, nausea, vomiting, new nasal congestion, and runny nose are also symptoms often associated with COVID-19. More information about COVID-19 symptoms is available from CDC.
  - In addition to COVID-19 symptoms, students must be excluded from school for signs of other infectious diseases, per existing school policy and protocols. See pages 9-11 of OHA/ODE <u>Communicable Disease Guidance for Schools</u>.
  - Emergency signs that require immediate medical attention:
    - Trouble breathing
    - o Persistent pain or pressure in the chest
    - New confusion or inability to awaken

#### **Hybrid/Onsite Plan**

#### **Screening Students:**

Students will be visually screened by the staff when arriving on campus and/or taking the bus. When the screening indicates that a student may be symptomatic, the student is directed to the office. \*Follow established protocol from CDMP (see section 1a). Screening will include updating the cohort or individual student logs.

#### **Entry**

During limited in person instruction students will enter outside doors directly into their assigned classrooms. Cohorts will be no more than 20 students and they will be on campus for no more than two consecutive hours.

#### **Screening Staff:**

 Staff are required to report to the administrator when they may have been exposed to COVID-19.

- Bluish lips or face (lighter skin); greyish lips or face (darker skin)
- o Other severe symptoms
- ☐ Screen all students and staff for symptoms on entry to bus/school every day. This can be done visually and/or with confirmation from a parent/caregiver/guardian. Staff members can self-screen and attest to their own health.
  - Anyone displaying or reporting the primary symptoms of concern must be isolated (see section 1i of the *Ready Schools*, *Safe Learners* guidance) and sent home as soon as possible.
     See table "Planning for COVID-19 Scenarios in Schools."
  - Additional guidance for nurses and health staff.
- Follow LPHA advice on restricting from school any student or staff known to have been exposed (e.g., by a household member) to COVID-19. See table "Planning for COVID-19 Scenarios in Schools."
- Staff or students with a chronic or baseline cough that has
   worsened or is not well-controlled with medication must be
   excluded from school. Do not exclude staff or students who have
   other symptoms that are chronic or baseline symptoms (e.g.,
   asthma, allergies, etc.) from school.
- Hand hygiene on entry to school every day: wash with soap and water for 20 seconds or use an alcohol-based hand sanitizer with 60-95% alcohol.

#### Hybrid/Onsite Plan

 Staff are required to report to the administrator when they have primary or secondary symptoms related to COVID-19.

Mapleton SD will teach and regularly remind staff and students to wash with soap and water for 20 seconds or use an alcohol-based hand sanitizer with 60-95% alcohol. Hand sanitizer use will be required at school and bus entry.

#### 1g. VISITORS/VOLUNTEERS

#### **OHA/ODE** Requirements

- □ Restrict non-essential visitors/volunteers.
  - Examples of essential visitors include: DHS Child Protective Services, Law Enforcement, etc.
  - Examples of non-essential visitors/volunteers include: Parent Teacher Association (PTA), classroom volunteers, etc.
- Screen all visitors/volunteers for symptoms upon every entry. Restrict from school property any visitor known to have been exposed to COVID-19. <u>See table "Planning for COVID-19 Scenarios</u> in Schools."
- Visitors/volunteers must wash or sanitize their hands upon entry and exit.
- Visitors/volunteers must maintain six-foot distancing, wear face coverings, and adhere to all other provisions of this guidance.

#### Hybrid/Onsite Plan

Visitors/Volunteers will be unable to work in schools, or complete other volunteer activities that require in person interaction, at this time. Adults in schools are limited to essential personnel only.

#### 1h. FACE COVERINGS, FACE SHIELDS, AND CLEAR PLASTIC BARRIERS

#### OHA/ODE Requirements

- Face coverings or face shields for all staff, contractors, other service providers, visitors or volunteers following <a href="CDC guidelines for Face Coverings">CDC guidelines for Face Coverings</a>. Individuals may remove their face coverings while working alone in private offices. Face shields are an acceptable alternative when a person has a medical condition that prevents them from wearing a mask or face covering, when people need to see mouth and tongue motions in order to communicate, or when an individual is speaking to an audience for a short period of time and clear communication is otherwise not possible.
- Face coverings or face shields for all students in grades Kindergarten and up following CDC guidelines for Face Coverings. Face shields are an acceptable alternative when a student has a medical condition that prevents them from wearing a mask or face covering, or when people need to see the student's mouth and tongue motions in order to communicate.
- Face coverings should be worn both indoors and outdoors, including during outdoor recess.

#### **Hybrid/Onsite Plan**



All staff and students will be required to wear face coverings or a face shield with a face covering unless they have medical conditions and a physician's orders that prevents them from doing so. In these cases, a

- Group mask breaks" or "full classroom mask breaks" are not allowed. If a student removes a face covering, or demonstrates a need to remove the face covering for a short-period of time:
  - Provide space away from peers while the face covering is removed. In the classroom setting, an example could be a designated chair where a student can sit and take a 15 minute "sensory break;"
    - Students must not be left alone or unsupervised;
    - Designated area or chair must be appropriately distanced from other students and of a material that is easily wiped down for disinfection after each use;
  - Provide additional instructional supports to effectively wear a face covering;
  - Provide students adequate support to re-engage in safely wearing a face covering;
  - Students cannot be discriminated against or disciplined for an inability to safely wear a face covering during the school day.
- Face masks for school RNs or other medical personnel when providing direct contact care and monitoring of staff/students displaying symptoms. School nurses shall also wear appropriate Personal Protective Equipment (PPE) for their role.
  - Additional guidance for nurses and health staff.

#### Protections under the ADA or IDEA:

- ☑ If any student requires an accommodation to meet the requirement for face coverings, districts and schools must limit the student's proximity to students and staff to the extent possible to minimize the possibility of exposure. Appropriate accommodations could include:
  - Offering different types of face coverings and face shields that may meet the needs of the student.
  - Spaces away from peers while the face covering is removed; students must not be left alone or unsupervised.
  - Short periods of the educational day that do not include wearing the face covering, while following the other health strategies to reduce the spread of disease.
  - Additional instructional supports to effectively wear a face covering.
- For students with existing medical conditions and a physician's orders to not wear face coverings, or other health related concerns, schools/districts must not deny any in-person instruction.
- Schools and districts must comply with the established IEP/504 plan prior to the closure of in-person instruction in March of 2020, or the current plan in effect for the student if appropriately developed after March of 2020.
  - If a student eligible for, or receiving services under a 504/IEP, cannot wear a face covering due to the nature of the disability, the school or district must:
    - Review the 504/IEP to ensure access to instruction in a manner comparable to what was originally established in the student's plan including on-site instruction with accommodations or adjustments.
    - Not make placement determinations solely on the inability to wear a face covering.
    - 3. Include updates to accommodations and modifications to support students in plans.
  - For students protected under ADA/IDEA, who abstain from wearing a face covering, or students whose families determine the student will not wear a face covering, the school or district must:

#### 1i. ISOLATION AND QUARANTINE

#### OHA/ODE Requirements

#### Protocols for exclusion and isolation for sick students and staff whether identified at the time of bus pick-up, arrival to school, or at any time during the school day.

- Protocols for screening students, as well as exclusion and isolation protocols for sick students and staff identified at the time of arrival or during the school day.
  - Work with school nurses, health care providers, or other staff
    with expertise to determine necessary modifications to areas
    where staff/students will be isolated. If two students present
    COVID-19 symptoms at the same time, they must be isolated
    at once. If separate rooms are not available, ensure that six
    feet distance is maintained. Do not assume they have the
    same illness.
  - Consider required physical arrangements to reduce risk of disease transmission.
  - Plan for the needs of generally well students who need medication or routine treatment, as well as students who may show signs of illness.
  - Additional guidance for nurses and health staff for providing care to students with complex needs.
- Students and staff who report or develop symptoms must be isolated in a designated isolation area in the school, with adequate space and staff supervision and symptom monitoring by a school nurse, other school-based health care provider or school staff until they are able to go home. Anyone providing supervision and symptom monitoring must wear appropriate face covering or face shields.
  - School nurse and health staff in close contact with symptomatic individuals (less than 6 feet) must wear a

#### Hybrid/Onsite Plan

- A health room connected to the office, with internal and external doorways, will serve as isolation room.
- An isolation log will be kept, and medical grade PPE available for interaction with any student or staff member demonstrating primary or secondary symptoms. Our school principal will consult weekly with nurse on updates for plan and isolation measures taken to that point.
- All students who become ill at school will remain at school supervised by staff until parents can pick them up in the designated isolation room.
- While exercising caution to maintain safety is appropriate when working with children exhibiting symptoms, it is also critical that staff maintain sufficient composure and disposition so as not to unduly worry a student or family.
- The isolation room will be thoroughly cleaned and disinfected, by staff wearing medical grade PPE, once the student is picked up from the isolation room.
- Staff will maintain student confidentiality as appropriate.
- Daily logs must be maintained containing the following:
  - Name of students sent home for illness, cause of illness, time of onset; and
  - Name of students visiting the office for illness symptoms, even if not sent home.
- Staff and students with known or suspected COVID-19, or displaying COVID-19 symptoms per current OHA guidance, CDC guidance, or LPHA guidance, cannot remain at school and should return only after their symptoms resolve and they are physically

medical-grade face mask. Other Personal Protective Equipment (PPE) may be needed depending on symptoms and care provided. Consult a nurse or health care professional regarding appropriate use of PPE. Any PPE used during care of a symptomatic individual must be properly removed and disposed of prior to exiting the care space.

- After removing PPE, hands shall be immediately cleaned with soap and water for at least 20 seconds. If soap and water are not available, hands can be cleaned with an alcohol-based hand sanitizer that contains 60-95% alcohol.
- If able to do so safely, a symptomatic individual shall wear a face covering.
- To reduce fear, anxiety, or shame related to isolation, provide a clear explanation of procedures, including use of PPE and handwashing.
- Establish procedures for safely transporting anyone who is sick to their home or to a health care facility.
- Staff and students who are ill must stay home from school and must be sent home if they become ill at school, particularly if they have COVID-19 symptoms. Refer to table in <u>"Planning for COVID-19 Scenarios in Schools."</u>
- Involve school nurses, School Based Health Centers, or staff with related experience (Occupational or Physical Therapists) in development of protocols and assessment of symptoms (where staffing exists).
- Record and monitor the students and staff being isolated or sent home for the LPHA review.

## 2. Facilities and School Operations

Some activities and areas will have a higher risk for spread (e.g., band, choir, science labs, locker rooms). When engaging in these activities within the school setting, schools will need to consider additional physical distancing or conduct the activities outside (where feasible). Additionally, schools should consider sharing explicit risk statements for instructional and extra-curricular activities requiring additional considerations (see section 5f of the *Ready Schools, Safe Learners* guidance).

#### 2a. ENROLLMENT

(Note: Section 2a does not apply to private schools.)

#### **OHA/ODE Requirements**

- ☑ Enroll all students (including foreign exchange students) following the standard Oregon Department of Education guidelines.
- ☐ The temporary suspension of the 10-day drop rule does not change the rules for the initial enrollment date for students:
  - The ADM enrollment date for a student is the first day of the student's actual attendance.
  - A student with fewer than 10 days of absence at the beginning of the school year may be counted in membership prior to the first day of attendance, but not prior to the first calendar day of the school year.
  - If a student does not attend during the first 10 session days of school, the student's ADM enrollment date must reflect the student's actual first day of attendance.
  - Students who were anticipated to be enrolled, but who do not attend at any time must not be enrolled and submitted in ADM.

#### Hybrid/Onsite Plan

- All students will be enrolled following the Oregon Department of Education guidelines.
- No student will be dropped for non-attendance, as the 10-day drop has been suspended for the year.

Mapleton SD will not be accepting inter-district transfers once LIPI and hybrid instruction begins.

#### **2b. ATTENDANCE**

(Note: Section 2b does not apply to private schools.)

#### OHA/ODE Requirements

OHA/ODE Requirement

- ☑ Grades K-5 (self-contained): Attendance must be taken at least once per day for all students enrolled in school, regardless of the instructional model (On-Site, Hybrid, Comprehensive Distance Learning, online schools).
- ☑ Grades 6-12 (individual subject): Attendance must be taken at least once for each scheduled class that day for all students enrolled in school, regardless of the instructional model (On-Site, Hybrid, Comprehensive Distance Learning, online schools).
- Alternative Programs: Some students are reported in ADM as enrolled in a non-standard program (such as tutorial time), with hours of instruction rather than days present and days absent. Attendance must be taken at least once for each scheduled interaction with each student, so that local systems can track the student's attendance and engagement. Reported hours of instruction continue to be those hours in which the student was present.
- Online schools that previously followed a two check-in per week attendance process must follow the Comprehensive Distance Learning requirements for checking and reporting attendance.
- Provide families with clear and concise descriptions of student attendance and participation expectations as well as family involvement expectations that take into consideration the home environment, caregiver's work schedule, and mental/physical health.

#### Hybrid/Onsite Plan

Attendance is taken daily for all students enrolled in school.

Calls are made daily for absent students in order to provide care and connection and any required supports for participation.

- Attendance policies and plans will encourage staff and students to stay home if someone in their house is sick.
- Secretary will notify the principal when the absence rate has increased by 20% or more.
- The principal (or designee) will report this increase to the nurse.

#### 2c. TECHNOLOGY

#### OHA/ODE Requirements

- ☑ Update procedures for district-owned or school-owned devices to match cleaning requirements (see section 2d of the *Ready Schools, Safe Learners* guidance).
- Procedures for return, inventory, updating, and redistributing district-owned devices must meet physical distancing requirements.

#### **Hybrid/Onsite Plan**

- Inventory district technology and internet connectivity resources
- Plan for technology support and replacement, including budget.
- Students will bring their Chromebooks to campus and devices will not be shared between students. As well, they will be provided their own headphones, which will never be shared.

#### 2d. SCHOOL SPECIFIC FUNCTIONS/FACILITY FEATURES

#### **OHA/ODE Requirements**

- Handwashing: All people on campus shall be advised and encouraged to frequently wash their hands or use hand sanitizer.
- Equipment: Develop and use sanitizing protocols for all equipment used by more than one individual or purchase equipment for individual use.
- Events: Cancel, modify, or postpone field trips, assemblies, athletic events, practices, special performances, school-wide parent meetings and other large gatherings to meet requirements for physical distancing.
- Transitions/Hallways: Limit transitions to the extent possible. Create hallway procedures to promote physical distancing and minimize gatherings.
- Personal Property: Establish policies for personal property being brought to school (e.g., refillable water bottles, school supplies, headphones/earbuds, cell phones, books, instruments, etc.). If personal items are brought to school, they must be labeled prior to entering school and use shall be limited to the item owner.

#### **Hybrid/Onsite Plan**

- Hand Washing: All students will have access to hand washing stations, with frequent hand washing opportunities provided throughout the school day. Signage to encourage handwashing is up across the school.
- Equipment: All classroom supplies and PE equipment will be cleaned and sanitized before use by another cohort group.
- Safety Drills: During fire drills (and all other safety drills), all cohort classes will be physically distanced during exit, recovery, and reentry procedures.
- **Events:** Field trips will be designed virtually for the school year. All assemblies, special performances, school-wide parent meetings and other large gatherings will be cancelled, held in a virtual format, or designed in a manner that allows appropriate physical distancing to be maintained throughout.
- Transitions/Hallways: Hallway traffic direction marked to show travel flow.
  - Classroom line up: students line up in cohort classes outside and in the gym in designated areas, keeping more than 6 feet between cohort group/each other.
    - Line up areas are to be marked with visual cues to indicate adequate physical distance.
- Personal Property: During LIPI, students will be limited to bringing only those personal items that directly support instruction, these will be communicated by the teacher.
- Restrooms: During limited in person instruction, all bathrooms
  will be cleaned/disinfected by custodial staff after each cohort.
  Custodians will use signage to open and close bathrooms and
  indicate that it has been cleaned/disinfected. Students will be
  able to use the bathroom as needed; maintaining proper
  distancing and handwashing (signage).

#### **2e. ARRIVAL AND DISMISSAL**

#### OHA/ODE Requirements

- Physical distancing, stable cohorts, square footage, and cleaning requirements must be maintained during arrival and dismissal procedures.
- Create schedule(s) and communicate staggered arrival and/or dismissal times.
- Assign students or cohorts to an entrance; assign staff member(s) to conduct visual screenings (see section 1f of the *Ready Schools*, *Safe Learners* guidance).
- Ensure accurate sign-in/sign-out protocols to help facilitate contact tracing by the LPHA. Sign-in procedures are not a replacement for entrance and screening requirements. Students entering school after arrival times must be screened for the primary symptoms of concern.
  - Eliminate shared pen and paper sign-in/sign-out sheets.
  - Ensure hand sanitizer is available if signing children in or out on an electronic device.
- Ensure alcohol-based hand sanitizer (with 60-95% alcohol) dispensers are easily accessible near all entry doors and other high-traffic areas. Establish and clearly communicate procedures for keeping caregiver drop-off/pick-up as brief as possible.

# Hybrid/Onsite Plan Screening Students:

Students will be visually screened by the staff upon arrival. When the screening indicates that a student may be symptomatic, the student is directed to the office. \*Follow established protocol from CDMP (see section 1a). Screening will include updating the cohort or individual student logs.

#### **Entry**

#### **All Students and Cohorts**

- Each teacher/staff member will use a sign-in/sign-out protocol to help facilitate contact tracing.
  - Staff will fill in the information and not allow a shared pen/paper.
  - Hand sanitizer will be available at reception to use in conjunction with arrival/dismissal and signin/sign-out.
- Hand sanitizer dispensers will be placed near all entry doors and other high-traffic areas.
- Families are expected to stay in their cars during pick up and drop off times.
- Mark specific areas and designate one-way traffic flow for transitions of traffic for vehicles and on-foot.

#### 2f. CLASSROOMS/REPURPOSED LEARNING SPACES

OHA	ODF Requirements

- Seating: Rearrange student desks and other seat spaces so that staff and students' physical bodies are six feet apart to the maximum extent possible while also maintaining 35 square feet per person; assign seating so students are in the same seat at all times.
- Materials: Avoid sharing of community supplies when possible (e.g., scissors, pencils, etc.). Clean these items frequently. Provide hand sanitizer and tissues for use by students and staff.
- Handwashing: Remind students (with signage and regular verbal reminders from staff) of the utmost importance of hand hygiene and respiratory etiquette. Respiratory etiquette means covering coughs and sneezes with an elbow or a tissue. Tissues shall be disposed of in a garbage can, then hands washed or sanitized immediately.
  - Wash hands with soap and water for 20 seconds or use an alcohol-based hand sanitizer with 60-95% alcohol.

#### **Hybrid/Onsite Plan**

- Seating: Rearrange student desks and tables to at least six feet apart; assign seating so students are in the same seat at all times.
- Materials: Each classroom will limit sharing of community supplies when possible (e.g., scissors, pencils, etc.). If needed to share, these items will be cleaned frequently. Hand sanitizer and tissues will be available for use by students and staff.
- Hand Washing: Students will wash hands frequently throughout the day.
- Respiratory Etiquette: School staff will consistently teach and reinforce the need for ongoing respiratory etiquette.
- Furniture: All upholstered furniture and soft seating has been removed from the classrooms.
- Classroom Procedures: All PK-6 classes will use an assigned cubby or storage spaces for individual student belongings. Shared restroom/hall passes will not be used. All shared spaces (e.g., computer lab, library, gymnasium) will be cleaned between cohort use.
- Seating: Each class and hallway will have visual aids (e.g., painter's tape, stickers, etc.) to illustrate traffic flow, appropriate spacing, assigned seating areas.
- Environment: When possible, windows will be open in the classroom before students arrive and after students leave. Each classroom will hold classes outside when possible and encourage students to spread out.

#### 2g. PLAYGROUNDS, FIELDS, RECESS, BREAKS, AND RESTROOMS

#### OHA/ODE Requirements

- Keep school playgrounds closed to the general public until park playground equipment and benches reopen in the community (see Oregon Health Authority's <a href="Specific Guidance for Outdoor Recreation Organizations">Specific Guidance for Outdoor Recreation Organizations</a>).
- After using the restroom students must wash hands with soap and water for 20 seconds. Soap must be made available to students and staff.
- Before and after using playground equipment, students must wash hands with soap and water for 20 seconds <u>or</u> use an alcohol-based hand sanitizer with 60-95% alcohol.
- Designate playground and shared equipment solely for the use of one cohort at a time. Outdoor playground structures require normal routine cleaning and do not require disinfection. Shared equipment (balls, jump ropes, etc.) should be cleaned and disinfected at least daily in accordance with <u>CDC guidance</u>.
- Cleaning requirements must be maintained (see section 2j of the Ready Schools, Safe Learners guidance).

#### Hybrid/Onsite Plan

Playground(s) will remain closed for public use. School will post adequate signs sharing this information with the public. Classes may use the playground for recess on a staggered schedule throughout the school day.

Outdoor play will not be a part of limited in person instruction; however, the following protocols are in place for our district.

- Playground supplies: Each cohort group will use their own playground supplies (e.g., balls, jump ropes, etc.).
- Students must wash hands before and after using playground equipment.
- Recess activities will be planned to support physical distancing and maintain stable cohorts. This can include limiting the number of students on one piece of equipment, at one game, etc.

Given the lessened capacity for equipment use due to cohorting and physical distancing requirements, teachers will need to set

#### **2h. MEAL SERVICE/NUTRITION**

#### OHA/ODE Requirements

- ☑ Include meal services/nutrition staff in planning for school reentry.
- ☑ Prohibit self-service buffet-style meals.
- ☑ Prohibit sharing of food and drinks among students and/or staff.
- At designated meal or snack times, students may remove their face coverings to eat or drink but must maintain six feet of physical distance from others, and must put face coverings back on after finishing the meal or snack.
- Staff serving meals and students interacting with staff at mealtimes must wear face coverings (see section 1h of the *Ready Schools, Safe Learners* guidance).
- Students must wash hands with soap and water for 20 seconds or use an alcohol-based hand sanitizer with 60-95% alcohol before meals and shall be encouraged to do so after.
- Appropriate daily cleaning of meal items (e.g., plates, utensils, transport items).
- Cleaning and sanitizing of meal touch-points and meal counting system between stable cohorts.
- Adequate cleaning and disinfection of tables between meal periods.
- Since staff must remove their face coverings during eating and drinking, staff must eat snacks and meals independently, and not in staff rooms when other people are present. Consider staggering times for staff breaks, to prevent congregation in shared spaces.

#### **Hybrid/Onsite Plan**

During Limited In person Instruction, meals will be provided/available to all students through CDL logistics, those who are on site will be able to access breakfast or lunch, as grab and go, as appropriate, remaining with their assigned cohort only.

Cohorts will be maintained by physical distancing even in break periods.

Cleaning and sanitizing of meal areas by the staff monitoring the area will occur after any student eats on campus.

Staff are required to eat separate from students, outside when weather permits, and to maintain distancing from other staff members during meals.

Students will wash their hands before and after meals, if eating on campus.

#### 2i. TRANSPORTATION

#### OHA/ODE Requirements

- Include transportation departments (and associated contracted providers, if used) in planning for return to service.
- Buses are cleaned frequently. Conduct targeted cleanings between routes, with a focus on disinfecting frequently touched surfaces of the bus (see section 2j of the *Ready Schools, Safe Learners* guidance).
- Staff must use hand sanitizer (containing between 60-95% alcohol) in between helping each child and when getting on and off the vehicle. Gloves are not recommended; hand sanitizer is strongly preferred. If hand sanitizer is not available, disposable gloves can be used and must be changed to a new pair before helping each child.
- Develop protocol for loading/unloading that includes visual screening for students exhibiting symptoms and logs for contacttracing. This must be done at the time of arrival and departure.

#### **Hybrid/Onsite Plan**

- LIPI transportation cohorts are limited to 20, and these cohorts count as one of the two allowable cohorts for each student each week. Additionally, bus drivers are limited to interaction with up to three cohorts daily, and five weekly.
- Bus drivers are required to use face coverings at all times. Facial coverings will be provided for drivers. Coverings must be in use when stopped but can be lifted while driving.
- Each bus driver/staff will be required to:
  - Visually screen students for illness
    - follow entry and screening procedures
  - Maintain logs for contact-tracing using procedures from 1a above.
- Each bus will have:
  - One student per seat every other seat

- If a student displays COVID-19 symptoms, provide a face covering (unless they are already wearing one) and keep six feet away from others. Continue transporting the student.
  - The symptomatic student shall be seated in the first row of the bus during transportation, and multiple windows must be opened to allow for fresh air circulation, if feasible.
  - The symptomatic student shall leave the bus first. After all students exit the bus, the seat and surrounding surfaces must be cleaned and disinfected.
- If arriving at school, notify staff to begin isolation measures.
  - If transporting for dismissal and the student displays an onset of symptoms, notify the school.
- Consult with parents/guardians of students who may require additional support (e.g., students who experience a disability and require specialized transportation as a related service) to appropriately provide service.
- ☑ Drivers must wear masks or face coverings while driving, unless the mask or face covering interferes with the driver's vision (e.g., fogging of eyeglasses). Drivers must wear face coverings when not actively driving and operating the bus, including while students are entering or exiting the vehicle. A face shield may be an acceptable alternative, as stated in Section 1h of the *Ready Schools, Safe Learners* guidance.
- Inform parents/guardians of practical changes to transportation service (i.e., physical distancing at bus stops and while loading/unloading, potential for increased route time due to additional precautions, sanitizing practices, and face coverings).
- Face coverings or face shields for all students in grades
  Kindergarten and up following CDC guidelines applying the
  guidance in section 1h of the Ready Schools, Safe Learners
  guidance to transportation settings.

#### Hybrid/Onsite Plan

- Recommend three (3) feet of physical distance between passengers
- 3 feet of physical distance between the driver and passengers (except during boarding and in assisting those with mobility devices); reinforce this requirement by cordoning off seats as appropriate.
- An isolation seat will be assigned in the first row on each bus.
- Windows will be cracked in front at all times.
- Use visual cues (e.g., floor decals, colored tape or signs) to discourage students from standing and sitting within three (3) feet of other passengers, drivers and other transit employees on the bus.
- Clean and sanitize buses between cohort routes.

Meet with parents/guardians of students who may require additional support (e.g., students who experience a disability and require specialized transportation as a related service) to appropriately provide service.

#### 2j. CLEANING, DISINFECTION, AND VENTILATION

#### OHA/ODE Requirements

- Clean, sanitize, and disinfect frequently touched surfaces (e.g. door handles, sink handles, drinking fountains, transport vehicles) and shared objects (e.g., toys, games, art supplies) between uses multiple times per day. Maintain clean and disinfected (CDC guidance) environments, including classrooms, cafeteria settings and restrooms.
- Outdoor playground structures require normal routine cleaning and do not require disinfection. Shared equipment should be cleaned and disinfected at least daily in accordance with <u>CDC</u> guidance.
  - Apply disinfectants safely and correctly following labeling direction as specified by the manufacturer. Keep these products away from students.
- ☑ To reduce the risk of asthma, choose disinfectant products on the EPA List N with asthma-safer ingredients (e.g. hydrogen peroxide, citric acid, or lactic acid) and avoid products that mix these with asthma-causing ingredients like peroxyacetic acid, sodium hypochlorite (bleach), or quaternary ammonium compounds.
- Schools with HVAC systems must evaluate the system to minimize indoor air recirculation (thus maximizing fresh outdoor air) to the extent possible. Schools that do not have mechanical ventilation systems shall, to the extent possible, increase natural ventilation by opening windows and interior doors before students arrive and after students leave, and while students are present. Do not prop open doors that can pose a safety or security risk to students and staff (e.g., exterior doors and fire doors that must remain closed).

#### **Hybrid/Onsite Plan**

- All frequently touched surfaces (e.g., playground equipment, door handles, sink handles, transport vehicles) and shared objects (e.g., toys, games, art supplies) will be cleaned between uses by different cohorts, but not less than once daily.
  - Follow <u>CDC guidelines</u> for cleaning.
- Ventilation systems will be checked and maintained monthly by maintenance staff.
- Any room with in person instruction will have an open window or door.

Maintenance has a regular cleaning schedule and will use signage to indicate that an area has been sanitized and is ready for use by a new cohort.

#### **2m. SCHOOL EMERGENCY PROCEDURES AND DRILLS**

#### OHA/ODE Requirements

☑ In accordance with <u>ORS 336.071</u> and <u>OAR 581-022-2225</u> all schools (including those operating a Comprehensive Distance Learning model) are required to instruct students on emergency procedures. Schools that operate an On-Site or Hybrid model need to instruct and practice drills on emergency procedures so that students and staff can respond to emergencies.

Student transportation off-campus is limited to medical care.

- At least 30 minutes in each school month must be used to instruct students on the emergency procedures for fires, earthquakes (including tsunami drills in appropriate zones), and safety threats.
- Fire drills must be conducted monthly.
- Earthquake drills (including tsunami drills and instruction for schools in a tsunami hazard zone) must be conducted two times a year.
- Safety threats including procedures related to lockdown, lockout, shelter in place and evacuation and other appropriate actions to take when there is a threat to safety must be conducted two times a year.
- Drills can and should be carried out as close as possible to the procedures that would be used in an actual emergency. For

## 3. Response to Outbreak
